

## (i) PROPOSED GRANT OF GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES (ii) PROPOSED RE-ELECTION OF RETIRING DIRECTORS AND (iii) NOTICE OF 2021 AGM

#### 1. INTRODUCTION

The purpose of this circular is to provide you with information regarding the resolutions to be proposed at the 2021 AGM for the grant to the Directors of the general mandate to issue new Shares and the Share Repurchase Mandate; the re-election of the retiring Directors and to give you notice of the 2021 AGM.

#### 2. PROPOSED GRANT OF GENERAL MANDATE TO ISSUE NEW SHARES

At the Annual General Meeting, an ordinary resolution will also be proposed that the Directors be granted the Issue Mandate to issue Shares. The Issue Mandate will represent up to 20% of the aggregate number of the issued Shares as at the date of passing of the ordinary resolution in relation thereof. Based on 4,368,995,668 Shares in issue as at the Latest Practicable Date and assuming no further Shares will be issued or repurchased prior to the date of the 2021 AGM, the Directors will be authorised to issue 873,799,133 Shares pursuant to the Issue Mandate.

Subject to the passing of the aforesaid ordinary resolutions of the Share Repurchase Mandate and the Issue Mandate, a separate ordinary resolution will also be proposed to authorise the Directors to allot, issue and deal with Shares in an amount not exceeding the aggregate number of Shares repurchased by the Company pursuant to the Share Repurchase Mandate.

#### 3. PROPOSED SHARE REPURCHASE MANDATE

An ordinary resolution will be proposed at the 2021 AGM to approve the grant of the Proposed Share Repurchase Mandate to the Directors to repurchase Shares representing up to 10% of the aggregate nominal amount of the share capital of the Company in issue as at the date of passing the Share Repurchase Resolution. The Proposed Share Repurchase Mandate will continue in force until the conclusion of the next annual general meeting of the Company or any earlier date as referred to in the proposed resolution no. 5 of the notice of the 2021 AGM. Shareholders should refer to the explanatory statement contained in Appendix I to this circular, which sets out further information in relation to the Share Repurchase Mandate.

#### 4. PROPOSED RE-ELECTION OF RETIRING DIRECTORS

Pursuant to the article no. 116 of the Articles, at each annual general meeting, one-third of the Directors shall retire from office by rotation and a retiring Director shall retain office until the close of the meeting at which he retires, and shall be eligible for re-election thereat. Pursuant to the article no. 119 of the Articles, any Director appointed from time to time shall hold office until the next annual general meeting and shall be eligible for re-election. In this connection, Mr. Xu Jun, Mr. Gordon Ng and Mr. Li Dapeng shall retire from office at the conclusion of the 2021 AGM and they, being eligible, will offer themselves for re-election.

Particulars of the retiring Directors subject to re-election at the 2021 AGM are set out in Appendix II to this circular.

#### 5. THE 2021 AGM

The notice of the 2021 AGM is set out on pages 12 to 16 of this circular. At the 2021 AGM, each of resolutions will be proposed to approve, inter alia, the grant of general mandate to issue new Shares and the Share Repurchase Mandate, and the re-election of retiring Directors.

A form of proxy for use at the 2021 AGM is accompanied with this circular. Whether or not you are able to attend the meeting, you are requested to complete the accompanying form of proxy in accordance with the instructions printed thereon and return it to Tricor Standard Limited, the Company's branch share registrar, at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong, as soon as practicable and in any event, not less than 48 hours before the time scheduled for holding the 2021 AGM. Completion and return of the form of proxy will not preclude you from attending and voting in person at the 2021 AGM should you so wish.

#### 6. VOTING BY POLL

All the resolutions set out in the notice of the 2021 AGM will be decided by poll in accordance with the Listing Rules and the Articles. The chairman of the 2021 AGM will explain the detailed procedures for conducting a poll at the commencement of the 2021 AGM.

The poll results will be published on the respective websites of the Company (www.energine.hk) and the Stock Exchange (www.hkexnews.hk) after the conclusion of the 2021 AGM.

#### 7. **RESPONSIBILITY STATEMENT**

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that, to the best of their knowledge and belief, the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this circular misleading.

#### 8. **RECOMMENDATION**

The Directors consider that the proposed resolutions regarding, inter alia, the grant to Directors of the general mandates to issue new Shares and repurchase Shares, and the re-election of the retiring Directors as set out in the notice of the 2021 AGM are all in the best interest of the Company and the Shareholders as a whole. Accordingly the Directors recommend the Shareholders to vote in favour of such resolutions to be proposed at the 2021 AGM.

## **APPENDIX I**

## EXPLANATORY STATEMENT ON THE SHARE REPURCHASE MANDATE

The following is the explanatory statement required to be sent to the Shareholders under Rule 10.06(1)(b) of the Listing Rules to enable them to make an informed decision on whether to vote for or against the Share Repurchase Resolution to be proposed at the 2021 AGM.

#### 1. SHARE CAPITAL

As at the Latest Practicable Date, the number of issued Shares of the Company comprised 4,368,995,668 Shares. Subject to the passing of the Share Repurchase Resolution and on the basis that no further Shares will be issued or repurchased prior to the Annual General Meeting, the Company would be allowed under the Share Repurchase Mandate to repurchase a maximum of 436,899,566 Shares representing not more than 10% of the number of issued Shares of the Company as at the Latest Practicable Date.

The Share Repurchase Mandate, if granted, will be effective until whichever is the earliest of (i) the conclusion of the next Annual General Meeting; (ii) the expiration of the period within which the next Annual General Meeting is required to be held by the Articles, the Companies Law or any applicable laws of the Cayman Islands; and (iii) the date on which such authority is revoked or varied by an ordinary resolution of the Shareholders in a general meeting of the Company.

#### 2. REASONS FOR REPURCHASE

The Directors believe that the Share Repurchase Mandate is in the best interests of the Company and its shareholders. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net value of the Company and its assets and/or its earnings per Share of the Company and will only be made when the Directors believe that such a repurchase will benefit the Company and its shareholders.

#### 3. FUNDING OF REPURCHASE

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its Articles, the Listing Rules and the law of the Cayman Islands. The law of the Cayman Islands provides that the amount to be repaid in connection with a share repurchase may be paid from the profits of the Company and/or the proceeds of a new issue of Shares made for the purpose of the repurchase or out of capital, if the Company can, immediately following such payment, pay its debts as they fall due in the ordinary course of business.

# EXPLANATORY STATEMENT ON THE SHARE REPURCHASE MANDATE

#### 4. EFFECT OF EXERCISING THE SHARE REPURCHASE MANDATE

Taking into account the current working capital position of the Company, the Directors consider that, if the Repurchase Mandate were to be exercised in full, it might have a material adverse effect on working capital or gearing position of the Company disclosed in the latest audited financial statements contained in the annual report for the year ended 31 December 2020. However, the Directors do not intend to make any repurchases to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements or the gearing position of the Company which in the opinion of the Directors are from time to time appropriate for the Company.

#### 5. MARKET PRICES

## **APPENDIX I**

#### 6. UNDERTAKING

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the powers of the Company to make repurchases pursuant to the Share Repurchase Resolution and in accordance with the Listing Rules and the applicable laws of the Cayman Islands.

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, their associates, have any present intention to sell any Shares to the Company or its subsidiaries under the Share Repurchase Mandate if such is approved by the Shareholders.

No connected persons (as defined in the Listing Rules) have notified the Company that they have a present intention to sell Shares to the Company or its subsidiaries, or have undertaken not to do so, in the event the Share Repurchase Mandate is approved by the Shareholders.

#### 7. EFFECT OF TAKEOVERS CODE AND PUBLIC FLOAT REQUIREMENTS

If on the exercise of the power to repurchase Shares pursuant to the Share Repurchase Mandate, a shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of Rule 32 of the Takeovers Code. As a result, a shareholder or group of shareholders acting in concert, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rules 26 and 32 of the Takeovers Code.

As at the Latest Practicable Date, Astrotech is interested in 2,649,244,000 Shares (representing approximately 60.64% of the total number of issued Shares of the Company as at the Latest Practicable Date). In the event the Directors exercise in full the power to repurchase Shares under the Share Repurchase Mandate, then (if the present shareholdings remains the same) the attributable interests of Astrotech would be increased to approximately 67.37% of the number of issued Shares of the Company. The Directors believe that such an increase will not give rise to an obligation of Astrotech to make a mandatory offer under Rule 26 of the Takeovers Code whilst maintaining the Shares held by the public no less than 25%.

Save as disclosed above, the Directors are currently not aware of any consequences which will arise under the Takeovers Code as a result of any purchase made under the Share Repurchase Mandate. Nevertheless, the Directors do not intend to exercise the Share Repurchase Mandate to such extent as would, in the circumstances, trigger any potential consequences under Rule 26 of the Takeover Codes. Under any circumstances, the Share Repurchase Mandate will not be exercised to such an extent that the number of Shares held by public would fall below 25%.

#### 8. SHARE REPURCHASES MADE BY THE COMPANY

There was no repurchase of Shares made by the Company or any of its subsidiaries during the six months immediately preceding the Latest Practicable Date.

#### APPENDIX II PARTICULARS OF THE DIRECTORS SUBJECT TO RE-ELECTION

The following are the biographical details of the retiring Directors proposed to be re-elected at the 2021 AGM.

**Mr. Xu Jun**, aged 52, master degree holder, qualified as a member of the Chinese Institute of Certified Public Accountants. Mr. Xu was appointed as an executive Director and financial controller with effect from 1 November 2014. Since November 2005, he had successively been the Chief Accountant with subsidiaries of CALT, namely, Long March Aerospace Control Engineering Corporation, CALT Institute 18, and Aerospace Research Institute of Materials & Processing Technology.

Mr. Xu has entered into a service contract with the Company with no specified length of tenure. The total amount of emoluments payable to Mr. Xu under the service contract is RMB810,000 per annum, which was determined with reference to his experience, qualifications, duties and responsibilities in the Company as well as the current market conditions. He is also eligible to receive benefits in kind, contribution to pension plans, discretionary bonuses.

**Mr. Gordon Ng**, aged 56, master degree holder, he was qualified as a solicitor in England and Wales in 1993 and Hong Kong in 1994. He has been the Head of Corporate Finance/Capital Market, Asia of an international law firm since July 2013. Prior to that, he had been a partner of Sidley Austin Brown & Wood, Hong Kong and CMS Cameron Mckenna, Hong Kong, Hogan & Hartson, Hong Kong and O'Melveny & Myers, Hong Kong. He is currently an independent nonexecutive director of Mainland Headwear Holdings Ltd. (stock code: 1100) and ZTE Corporation (stock code: 763), the companies listed on the Hong Kong Stock Exchange.

Mr. Ng entered into an appointment letter with Company as an independent non-executive Director for a term of three year subject to retire and re-elect pursuant to the Articles. He was entitled a director's fee amounting to HK\$250,000 per annum under the terms of the appointment letter.

Mr. Ng has acted as an independent non-executive Director for more than nine years. The Company has received from Mr. Ng a confirmation of independence according to Rule 3.13 of the Listing Rules. Throughout his directorship with the Company, Mr. Ng has participated in Board meetings and Board Committees meetings to offer impartial advice and exercise independent judgment, and has attended general meetings of the Company to gain a balanced understanding of the Shareholders' views. Mr. Ng has never engaged in any executive management of the Group. Taking into consideration the independent nature of his role and duties in the past years, the Board considers Mr. Ng to be independent under the Listing Rules although he has served the Company more than nine years. The Board believes that the continuous appointment of Mr. Ng as an independent non-executive Director will help to maintain the stability of the Board as Mr. Ng has, over time, gained valuable insight into the business strategy and policies of the Group.

## APPENDIX II PARTICULARS OF THE DIRECTORS SUBJECT TO RE-ELECTION

**Mr. Li Dapeng**, aged 64, PhD degree holder, processing extensive experience relating to system development in capital market, Mr. Li had been the Chief Architect with New York Mercantile Exchange during the years 2001 to 2003; Chief Information Officer, and Chairman of Technology Management Committee with Shanghai Futures Exchange during the years from 2003 to 2010; CEO and founder of Shanghai Global Financial Technology during the years 2010 to 2012; Senior Adviser to CEO with the Hong Kong Exchanges and Clearing Ltd. during the period from March 2013 to May 2015. He has been the Chief Information Officer of Haier Financial Group, offering the perspective on technology and risk management to the group since June 2015. Mr. Li is currently an independent non-executive director of LUZHENG FUTURES Company Limited (stock code: 1461).

Mr. Li entered into an appointment letter with Company as an independent non-executive Director for a term of three year subject to retire and re-elect pursuant to the Articles. He was entitled a director's fee amounting to HK\$250,000 per annum under the terms of the appointment letter.

Save as disclosed above, as at the Latest Practicable Date, each of the retiring Directors who stands for re-election at the 2021 AGM did not hold any directorships or major appointments in other public companies the securities of which are listed on any securities market in Hong Kong or overseas in the last three years, did not have any interest in the Shares or underlying Shares within the meaning of Part XV of the SFO and did not have any relationships with any Directors, senior management or substantial or controlling shareholders of the Company.

Each of Mr. Xu, Mr. Ng and Mr. Li has confirmed that there is no other information required to be disclosed pursuant to rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules and there are no other matters that need to brought to the attention of the Shareholders pursuant to rule 13.51(2) of the Listing Rules.

  - (iv) any adjustment, after the date of grant or issue of any options, rights to subscribe or other securities referred to above, in the price at which shares in the Company shall be subscribed, and/or in the number of shares in the Company which shall be subscribed, on exercise of relevant rights under such options, warrants or other securities, such adjustment being made in accordance with, or as contemplated by, the terms of such options, rights to subscribe or other securities; or

(v) a specified authority granted by the shareholders of the Company in general meeting,

shall not exceed 20 per cent. of the aggregate nominal amount of the share capital of the Company in issue at the date of passing of this resolution, and the said approval shall be limited accordingly; and

(d) for the purposes of this resolution:

"**Relevant Period**" means the period from the passing of this resolution until whichever is the earliest of:

- (i) the conclusion of the next annual general meeting of the Company;
- (ii) the expiry of the period within which the next annual general meeting of the Company is required by any applicable law or the Articles of Association of the Company to be held; or
- (iii) the revocation, variation or renewal of the authority given under this resolution by an ordinary resolution of the shareholders of the Company in general meeting.

"**Right Issue**" means an offer of shares in the Company, or an offer of warrants, options or other securities giving rights to subscribe for shares, open for a period fixed by the directors of the Company to holders of shares in the Company whose names appear on the register of members of the Company on a fixed record date in proportion to their then holdings of such shares (subject in all cases to such exclusions or other arrangements as the directors of the Company may deem necessary or expedient in relation to fractional entitlements or having regard to any restrictions or obligations under the laws of, or the requirements of any recognised regulatory body or any stock exchange in, any territory outside Hong Kong)."

#### 5. **"THAT**:

(a) subject to paragraph (b) below, the exercise by the directors of the Company during the Relevant Period (as hereinafter defined) of all powers of the Company to make repurchase of its own shares on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") or on any other stock exchange on which the shares of the Company may be listed and recognised by the Securities and Futures Commission of Hong Kong and the Stock Exchange for this purpose, subject to and in accordance with all applicable laws and the requirements of the Rules Governing the Listing of Securities on the Stock Exchange or any other stock exchange (as the case may be) and the Code on Takeovers and Mergers of the Securities and Futures Commission of Hong Kong be and is hereby generally and unconditionally approved;

- (b) the aggregate nominal amount of shares of the Company to be repurchased by the Company pursuant to paragraph (a) above during the Relevant Period (as hereinafter defined) shall not exceed 10 per cent. of the aggregate nominal amount of the share capital of the Company in issue at the date of passing of this resolution and the authority pursuant to paragraph (a) above shall be limited accordingly; and
- (c) for the purpose of this resolution:

"**Relevant Period**" means the period from the passing of this resolution until whichever is the earliest of:

- (i) the conclusion of the next annual general meeting of the Company;
- (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles, the Companies Law, or any other applicable laws of the Cayman Islands to be held; and
- (iii) the revocation, variation or renewal of the authority given under this resolution by an ordinary resolution of the shareholders of the Company in general meeting."
- 6. **"THAT** conditional upon the passing of resolution nos. 4 and 5, the general mandate granted to the directors of the Company and for the time being in force to exercise the powers of the Company to allot shares be and is hereby extended by the addition to the aggregate nominal amount of the share capital which may be allotted or agreed conditionally or unconditionally to be allotted by the directors of the Company pursuant to such general mandate of an amount representing the aggregate nominal amount of the share capital of the Company repurchased by the Company under the authority granted by the resolution set out as resolution no. 5, provided that such amount shall not exceed 10% of the aggregate nominal amount of the share capital of the Company in issue as at the date of passing of this resolution."
