\* Pursuant to the relevant provisions of the US\$500,000,000 Zero Coupon Convertible Bonds due 2018, immediately after the record date of the 2015 Final Dividend of 08 Jun 2016, the conversion prices had been adjusted from HK\$48.62 per Share to HK\$47.73 per Share as a result of the 2015 Final Dividend.

All other terms of the Convertible Bonds remain unchanged. The outstanding principal amount of the Bonds of US\$500,000,000 entitle the holders of the Bonds to convert into 79,778,897 new Shares was therefore changed to 81,266,499 new Shares after the aforesaid adjustment.
