On 20 May 2021, 375,681,838 Rights Shares were issued pursuant to the Rights Issue of one rights share for every two existing shares held on the record date as detailed in the prospectus of the Company dated 23 April 2021.

Note: Immediately before completion of the Rights Issue, there were 31,950,000 outstanding share options under the Share Option Scheme. As a result of the Rights Issue, the number of outstanding share options have been adjusted to 32,870,022 pursuant to the terms and conditions of the Share Option Scheme. Following the lapse of the adjusted share options during the month of 205,759 share options, the number of outstanding share options as at 31 May 2021 was 32,664,263.
