On 25 September 2013, EVA Limited, a wholly-owned subsidiary of the Company, accepted the BOC Facility Letter which contains certain specific performance obligations on the Controlling Shareholders.

This announcement is made by EVA Precision Industrial Holdings Limited (the "Company") in compliance with the disclosure requirements under Rule 13.18 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules").

BANKING FACILITIES PROVIDED BY BANK OF CHINA (HONG KONG) LIMITED

On 25 September 2013, EVA Limited, a wholly-owned subsidiary of the Company, accepted a facility letter issued by Bank of China (Hong Kong) Limited ("BOC") ("BOC Facility Letter"). Pursuant to BOC Facility Letter, BOC agrees to make available to EVA Limited a new term loan facility of HK\$50,000,000 which is repayable in three years from the end of the Availability Period (which is within six months from 29 August 2013). Together with the existing facilities which include another term loan with outstanding balance of HK\$70,000,000 as at 25 September 2013 and a final maturity date in April 2015, and a revolving loan of HK\$40,000,000, the total facility limit under BOC Facility Letter is HK\$160,000,000.

The following specific performance obligations are imposed on Mr. Zhang Hwo Jie, Mr. Zhang Jian Hua and Mr. Zhang Yaohua (together the "Controlling Shareholders") under BOC Facility Letter:

- (1) the Controlling Shareholders shall maintain not less than 35% of the issued share capital of the Company; and
- (2) Mr. Zhang Hwo Jie shall remain as the chairman of the board of directors and an executive director of the Company.

A breach of the aforesaid obligations will constitute an event of default under BOC Facility Letter whereupon all amounts (including principal and interest) due or owing by EVA Limited to BOC shall become immediately due and payable and BOC shall not be required to make any further advances of the banking facilities under BOC Facility Letter.

As at the date of this announcement, Mr. Zhang Hwo Jie, Mr. Zhang Jian Hua and Mr. Zhang Yaohua own 38%, 29% and 33% respectively of the issued share capital of Prosper Empire Limited, which in turn owns approximately 38.2% of the issued share capital of the Company. In addition, the Controlling Shareholders also hold, either personally or through other investment holding company, approximately 1.9% of the issued share capital of the Company.

In accordance with the Listing Rules, similar disclosure will also be included in the subsequent interim and annual reports of the Company for so long as the aforesaid specific performance obligations continue to exist.
