(2) GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

INTRODUCTION

The purpose of this document is to provide you with information regarding the resolutions to be proposed at the AGM involving (1) the re-election of retiring Directors and the continuous appointment of Mr. Lam Hiu Lo who has served the Company more than nine years as an independent non-executive Director; and (2) the grant to the Directors of general mandates to allot, issue and deal with additional Shares and to repurchase Shares.

(1) RE-ELECTION OF RETIRING DIRECTORS AND CONTINUOUS APPOINTMENT OF INDEPENDENT NON-EXECUTIVE DIRECTOR WHO HAS SERVED MORE THAN NINE YEARS

In accordance with article no. 84 of the Articles, Mr. Zhang Jian Hua and Mr. Lam Hiu Lo will retire by rotation at the AGM and, being eligible, have offered themselves for re-election.

In accordance with article no. 83(3) of the Articles, Ms. Zhang Yan Yi will hold office as a Director until the AGM and, being eligible, has offered herself for re-election.

The qualifications, previous experience and major appointments of all the Directors who stand for reelection at the AGM are set out in the "Directors and Senior Management Profile" section contained in the 2023 Annual Report which is sent to the Shareholders together with this document. The biographical details of each of the said Directors, as required to be disclosed pursuant to rule 13.74 of the Listing Rules, are set out below for the Shareholders' consideration.

1. Zhang Jian Hua (Former name: Wong Yat, Michael) (aged 49)

Mr. Zhang Jian Hua is the vice-chairman of the Group and a director of certain subsidiaries of the Group. He was one of the co-founders of the Group in 1993 and was appointed as a Director on 14 September 2005. Mr. Zhang Jian Hua is responsible for the Group's organisational structure, production facilities management and business risk monitoring. He previously worked for the tax bureau in Shenzhen, where he accumulated extensive experience in tax regulations and communications with government departments in China. He also possesses substantial experience in organisational planning, production facilities management and business risk monitoring in the industry of precision mould and component manufacturing. Mr. Zhang Jian Hua did not hold any directorship in other listed companies in the last three years.

As at the Latest Practicable Date, Mr. Zhang Jian Hua had personal interests in 664,000 Shares (within the meaning of Part XV of the SFO) and Options to subscribe for 1,700,000 Shares. Mr. Zhang Jian Hua is a brother of Mr. Zhang Hwo Jie and Mr. Zhang Yaohua, respectively the chairman of the Board and the chief executive of the Company and the uncle of Ms. Zhang Yan Yi, an executive Director. Save as disclosed above, Mr. Zhang Jian Hua does not have any relationship with any other Directors, senior management or substantial or controlling Shareholders or hold any other position with the Company or any member of the Group.

Mr. Zhang Jian Hua has entered into a service agreement with the Company for a term of two years commencing on 1 April 2024 which can be terminated by either party giving the other not less than one month's prior written notice. Mr. Zhang is subject to retirement by rotation and re-election at the annual general meeting of the Company under the Articles.

2. Mr. Lam Hiu Lo (aged 62)

Mr. Lam Hiu Lo was appointed as an independent non-executive Director on 11 January 2013. He is the chairman of the remuneration committee of the Company and a member of the Company's audit committee and nomination committee. Mr. Lam does not hold any other position with the Company or any member of the Group or have any relationship with any other Directors, senior management or substantial or controlling Shareholders.

Mr. Lam has over 30 years of experience in sales and marketing in China. Over the years, he has successfully built up a strong business and personal network in China. Mr. Lam is currently an executive director of Planetree International Development Limited (formerly known as Yugang International Limited), a public company listed on the Stock Exchange. Save as disclosed, Mr. Lam did not hold any directorship in other listed companies in the last three years.

As at the Latest Practicable Date, Mr. Lam had personal interests (within the meaning of Part XV of the SFO) in Options to subscribe for 400,000 Shares.

Mr. Lam has entered into a service agreement with the Company for a term of two years commencing from 11 January 2023 which can be terminated by either party giving to the other party not less than one month's prior written notice. Mr. Lam is subject to retirement by rotation and re-election at the annual general meeting of the Company under the Articles.

According to code provision B.2.3 of the Corporate Governance Code as set out in Appendix C1 to the Listing Rules, if an independent non-executive director has served more than nine years, his further appointment should be subject to a separate resolution to be approved by shareholders. Mr. Lam has acted as an independent non-executive Director for more than nine years. The Company has received from Mr. Lam a confirmation of independence according to rule 3.13 of the Listing Rules.

In the process of assessing the independence of Mr. Lam, the nomination committee of the Company has, in addition to the factors set out in rule 3.13 of the Listing Rules and the independence confirmation of Mr. Lam, considered (i) whether Mr. Lam can maintain his impartiality and independent judgment on matters concerning the Group despite his long service; (ii) his relationship with the executive Directors and other senior management of the Group; (iii) whether Mr. Lam's experience and networks remain relevant to the Group; and (iv) Mr. Lam's attendance records and contributions at Board meetings, Board committee meetings, and general meetings of the Company. Throughout his directorship with the Company, Mr. Lam has been consistent in offering impartial advice to and exercising independent judgment on matters concerning the Group, and has never engaged in any executive management of the Group. He has been serving on governance committees of the Board to scrutinise the Company's performance in meeting corporate governance goals. He has also been attending general meetings of the Company to gain a balanced understanding of the Shareholders' views. Taking into account his ability and consistency in providing impartial and

valuable advice to the Group, as well as the benefits to the Group which are attributable to his vast experience and strong networks in China, the Board considers Mr. Lam to be suitable in holding office as an independent non-executive Director.

3. Ms. Zhang Yan Yi (aged 27)

Ms. Zhang Yan Yi was appointed as an executive Director on 21 July 2013. Ms. Zhang graduated from Royal Holloway University of London and Durham University. She obtained a bachelor's degree in Science (Economics) (First Class Honors) at the Royal Holloway University of London in 2018 and a Master of Science (Management) degree at Durham University in 2020.

Ms. Zhang joined the Group in 2020 and she is mainly responsible for the Group's internal process and risk management. Ms. Zhang is also a director of certain subsidiaries of the Group. Ms. Zhang did not hold any directorship in other listed companies in the last three years.

As at the Latest Practicable Date, Ms. Zhang had personal interests (within the meaning of Part XV of the SFO) in Options to subscribe for 400,000 Shares. Ms. Zhang is a daughter of Mr. Zhang Hwo Jie, an executive Director and the chairman of the Board; and a niece of both Mr. Zhang Jian Hua, an executive Director and the vice chairman of the Board, and Mr. Zhang Yaohua, an executive Director and the chief executive of the Group. Save as disclosed above, Ms. Zhang does not have any relationship with any other Directors, senior management or substantial or controlling Shareholders or hold any other potions with the Company or any member of the Group.

Ms. Zhang has entered into a service agreement with the Company for a term of two years commencing from 21 July 2023 which can be terminated by either party giving to the other party not less than one month's prior written notice. Ms. Zhang is subject to retirement by rotation and re-election at the annual general meeting of the Company under the Articles.

Directors' Emoluments

- (a) Mr. Zhang Jian Hua is entitled under his service agreement to a basic annual salary of currently \$5,760,000 and a fixed 1-month year-end bonus of \$480,000.
- (b) Ms. Zhang Yan Yi is entitled under her service agreement to a basic annual salary of currently \$600,000 and a fixed 1-month year-end bonus of \$50,000.00.
- (c) Mr. Zhang Jian Hua and Ms. Zhang Yan Yi are also entitled under their respective service agreements to:
 - (i) a discretionary year-end bonus of an amount to be determined by the Board and the remuneration committee of the Company;
 - (ii) participate in any bonus scheme that may be introduced by the Company; and

- (iii) participate in the mandatory provident fund scheme of the Company and may also be entitled to other employees' benefits, including bonus and car allowance.
- (d) Mr. Lam Hiu Lo is entitled under his service agreement to receive an annual Director's fee of currently \$160,000.
- (e) The emoluments of all Directors are determined on the basis of the relevant Director's experience, level of responsibilities within the Group and the current market situation.

Save for the information set out in this section and in the 2023 Annual Report, there is no other matter that needs to be brought to the attention of the Shareholders or any information that should be disclosed under paragraphs (h) to (v) of rule 13.51(2) of the Listing Rules.

(2) GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

As the general mandates granted to the Directors to allot, issue, and deal with additional Shares and to repurchase Shares respectively pursuant to resolutions passed by the Shareholders at the Company's annual general meeting held on 18 May 2023 will lapse at the conclusion of the AGM, resolutions will be proposed at the AGM to renew the grant of these general mandates. The relevant resolutions, in summary, are:

- an ordinary resolution to grant to the Directors a general and unconditional mandate to allot, issue, and deal with additional securities of the Company (including, inter alia, offers, agreements, options, warrants or similar rights in respect thereof) not exceeding 20% of the aggregate number of the Company's issued Shares as at the date of passing the relevant resolution for the period from the close of the AGM until the conclusion of the next annual general meeting of the Company (or such earlier period as stated in the resolution) (the "Issue Mandate"). On the basis of 1,740,919,800 Shares in issue as at the Latest Practicable Date, and assuming no further Shares will be issued or repurchased by the Company on or before the date of the AGM, the Company would be allowed under the Issue Mandate to issue a maximum of 348,183,960 Shares;
- an ordinary resolution to grant to the Directors a general and unconditional mandate to exercise all the powers of the Company to repurchase such number of Shares not exceeding 10% of the aggregate number of the Company's issued Shares as at the date of passing the relevant resolution for the period from the close of the AGM until the conclusion of the next annual general meeting of the Company (or such earlier period as stated in the resolution) (the "Repurchase Mandate"). On the basis of 1,740,919,800 Shares in issue as at the Latest Practicable Date, and assuming no further Shares will be issued or repurchased by the Company on or before the date of the AGM, the exercise of the Repurchase Mandate in full would result in up to 174,091,980 Shares being repurchased by the Company; and
- conditional on the passing of the resolutions to grant the Issue Mandate and the Repurchase Mandate, an ordinary resolution to authorise the Directors to exercise the powers of the Company to allot, issue, and deal with additional securities under the Issue Mandate by adding those Shares repurchased by the Company pursuant to the Repurchase Mandate.

The explanatory statement providing the requisite information regarding the Repurchase Mandate as required to be sent to Shareholders under the Listing Rules is set out in Appendix I to this document.

(4) AGM AND POLL PROCEDURES

The notice convening the AGM is set out in Appendix II to this document. At the AGM, amongst others, ordinary resolutions will be proposed to approve (i) the re-election of the retiring Directors and the continuous appointment of Mr. Lam Hiu Lo who has served the Company more than nine years as an independent non-executive Director and (ii) the granting of the Issue Mandate and the Repurchase Mandate

A form of proxy for use at the AGM is enclosed with this document. Whether or not you intend to attend the AGM, you are requested to complete and return the form of proxy in accordance with the instructions printed thereon to the Company's principal place of business at Unit 8, 6th Floor, Greenfield Tower, Concordia Plaza, No. 1 Science Museum Road, Kowloon, Hong Kong as soon as possible and in any event not less than 48 hours before the time appointed for the holding of the AGM or any adjournment thereof. Completion and return of the form of proxy will not preclude you from attending and voting at the AGM should you so wish.

Pursuant to rule 13.39(4) of the Listing Rules, any votes of the Shareholders at a general meeting must be taken by poll. Accordingly, the resolutions to be proposed at the AGM will be voted by way of a poll by the Shareholders.

(5) **RECOMMENDATION**

The Directors consider that the proposed resolutions regarding the re-election of the retiring Directors and the continuous appointment of the independent non-executive Director who has been serving the Company more than nine years and the granting of the Issue Mandate and the Repurchase Mandate are in the best interests of the Company and its Shareholders as a whole. Accordingly, the Directors recommend Shareholders to vote in favour of the proposed resolutions.

EXPLANATORY STATEMENT FOR THE REPURCHASE MANDATE

This is the explanatory statement required by rule 10.06(1)(b) of the Listing Rules to be given to all Shareholders relating to a resolution to be proposed at the AGM authorizing the Repurchase Mandate.

1. EXERCISE OF THE REPURCHASE MANDATE

Exercise in full of the Repurchase Mandate, on the basis of 1,740,919,800 Shares in issue as at the Latest Practicable Date and assuming no further Shares will be issued or repurchased by the Company on or before the date of the AGM, could result in up to 174,091,980 Shares being repurchased by the Company during the period from the passing of the resolution relating to the Repurchase Mandate up to the earliest of (i) the conclusion of the next annual general meeting of the Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles or any applicable laws to be held; and (iii) the revocation, variation or renewal of the Repurchase Mandate by ordinary resolution of the Shareholders in general meeting.

2. REASONS FOR REPURCHASES

Repurchases of Shares will only be made when the Directors believe that such repurchases will benefit the Company and the Shareholders as a whole. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or its earnings per Share.

3. FUNDING OF REPURCHASES

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its Articles and the applicable laws of the Cayman Islands. Such funds include profits available for distribution.

4. GENERAL

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the latest published audited accounts as contained in the 2023 Annual Report) in the event that the Repurchase Mandate is exercised in full. However, the Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or on the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

5. DIRECTORS, THEIR CLOSE ASSOCIATES AND CORE CONNECTED PERSONS

As at the Latest Practicable Date, to the best knowledge of the Directors having made all reasonable enquiries, none of the Directors or any of their respective close associates have a present intention, in the event that the Repurchase Mandate is approved and exercised, to sell Shares to the Company. No core connected persons have notified the Company that they have a present intention to sell Shares to the Company, or have undertaken not to do so, in the event that the Repurchase Mandate is approved and exercised.

6. UNDERTAKING

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the Repurchase Mandate in accordance with the Listing Rules, the memorandum of association of the Company and the Articles and the applicable laws of the Cayman Islands.

7. THE HONG KONG CODE ON TAKEOVERS AND MERGERS

If as a result of a repurchase of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of the Takeovers Code. As a result, a Shareholder, or a group of Shareholders acting in concert (within the meaning under the Takeovers Code), depending on the level of increase in the Shareholder's interests, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with rule 26 of the Takeovers Code. A waiver of this provision would not normally be given except in extraordinary circumstances. As at the Latest Practicable Date, approximately 38.70% of the issued Shares was held by Prosper Empire Limited which is wholly-owned by Mr. Zhang Hwo Jie and his brother, Mr. Zhang Yaohua, respectively the chairman of the Group and an executive Director. In addition, Mr. Zhang Hwo Jie and Mr. Zhang Yaohua had or were taken or deemed to have an aggregate interest of approximately 4.51% of the issued Shares.

In the event that the Directors exercise in full the power to repurchase Shares which is proposed to be granted at the AGM and assuming no further Shares are issued by the Company, the interest of Prosper Empire Limited in the number of issued Shares would be increased from 38.70% to 43.00% thereby triggering an obligation to make a mandatory offer under rule 26 of the Takeover Code. The Directors, however, have no present intention of exercising the Repurchase Mandate to such extent as would result in an mandatory offer.

The Directors are not aware of any Shareholder, or group of Shareholders acting in concert, who will become obliged to make a mandatory offer as a result of repurchases of Shares.

8. SHARE REPURCHASES MADE BY THE COMPANY

During the six months immediately preceding the Latest Practicable Date, the Company has not repurchased any Shares (whether on the Stock Exchange or otherwise).

(c) the aggregate number of shares allotted or agreed conditionally or unconditionally to be allotted (whether pursuant to an option or otherwise) by the directors of the Company pursuant to the approval in paragraph (a), otherwise than pursuant to the shares of the Company issued as a result of a Rights Issue or pursuant to the exercise of options under the share option schemes of the Company or similar arrangement, or any scrip dividend or similar arrangement providing for the allotment of shares of the Company in lieu of the whole or part of the dividend on the shares of the Company in accordance with the Company's Articles of Association, shall not exceed 20 per cent. of the aggregate number of issued shares of the Company as at the date of passing of this resolution and the said approval shall be limited accordingly; and

(d) for the purposes of this resolution:

"Relevant Period" means the period from the date of passing of this resolution until whichever is the earliest of:

- (i) the conclusion of the next annual general meeting of the Company;
- (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles of Association of the Company or any applicable laws of the Cayman Islands to be held; or
- (iii) revocation or variation of the authority given under this resolution by ordinary resolution of the shareholders of the Company in general meeting.

"Rights Issue" means an offer of shares open for a period fixed by the directors of the Company to holders of shares of the Company on the register on a fixed record date in proportion to their holdings of such shares (subject to such exclusions or other arrangements as the directors of the Company may deem necessary or expedient in relation to fractional entitlements or having regard to any restrictions or obligations under the laws of, or the requirements of, any recognised regulatory body or any stock exchange in any territory outside Hong Kong)."

(a) subject to paragraph (b), the exercise by the directors of the Company during the Relevant Period of all the powers of the Company to repurchase shares of the Company on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") or on any other stock exchange on which the securities of the Company may be listed and recognised by the Securities and Futures Commission and the Stock Exchange for this purpose, subject to and in accordance with all applicable laws and requirements of the Rules Governing the Listing of Securities on the Stock Exchange or of any other stock exchange on which the securities of the Company may be listed as amended from time to time, be and is hereby generally and unconditionally approved;
