UNAUDITED OPERATING STATISTICS OF PROPERTIES OF THE GROUP FOR MARCH 2016

The board of directors (the “**Board**”) of Evergrande Real Estate Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that the Group’s contracted sales of properties for the month of March 2016 amounted to approximately RMB29.20 billion. The contracted sales area was approximately 3,282,000 square meters. The average contracted selling price of properties was RMB8,898 per square meter. The contracted sales amount, contracted sales area and average selling price for the month of March 2016 represented an increase of 113.0%, 81.0% and 17.7% over the same period in 2015, respectively, and represented an increase of 91.7%, 85.4% and 3.4% over February 2016, respectively.

The aggregate contracted sales of the Group’s properties for the period from January to March 2016 amounted to approximately RMB65.67 billion. The aggregate contracted sales area and average selling price amounted to approximately 7,504,000 square meters and RMB8,752 per square meter, respectively. The aggregate contracted sales amount, area and average selling price for the period from January to March 2016 represented an increase of 115.0%, 85.9% and 15.7% over the same period in 2015, respectively.

The above-mentioned sales data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collecting such sales information.
