**ANNOUNCEMENT IN RELATION TO
HENGDA REAL ESTATE'S INVOLVEMENT IN MATERIAL LITIGATION AND
FAILURE TO REPAY DEBTS DUE**

This announcement is made by China Evergrande Group (the “**Company**”) pursuant to Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

恒大地產集團有限公司 (Hengda Real Estate Group Company Limited*)(together with its subsidiaries, “**Hengda Real Estate**”), a principal subsidiary of the Company, announces the latest status of, among others, the material litigation it is involved in and its failure to repay debts due as follows:

Material litigation

As of the end of April 2023, Hengda Real Estate had a total of 1,426 pending litigation cases which involved more than RMB30 million each, with the total amount involved of approximately RMB349.553 billion.

Failure to repay debts due

As of the end of April 2023, Hengda Real Estate’s unpaid debts due (excluding onshore and offshore bonds) amounted to approximately RMB272.479 billion. In addition, as of the end of April 2023, Hengda Real Estate’s overdue commercial bills amounted to approximately RMB245.987 billion.

Disposal of real estate projects

As of the end of April 2023, Hengda Real Estate had completed the disposal of a total of 65 real estate projects through equity transfer, transfer of land and construction in progress, trust, nominee holding, etc.

New enforcement cases

During April 2023, there were 130 new enforcement cases against Hengda Real Estate, involving total amount of approximately RMB2.924 billion.

Freeze of equity interest

During April 2023, there were 27 new cases in which the equity interest in subsidiaries and investee companies held by Hengda Real Estate, as the party subject to enforcement, were frozen, and the total amount involved was approximately RMB26.552 billion.

Trading in the shares of the Company has been suspended since 9:00 a.m. on 21 March 2022. The trading in the shares of the Company will remain suspended until further notice.

Holders of the Company's securities and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.
