1. INTRODUCTION

The purpose of this circular is to provide you with information in respect of the resolutions to be proposed at the Annual General Meeting for the approval of (i) the re-election of retiring Directors; (ii) election of new Director; and (iii) the grant of the Repurchase Mandate and the Issue Mandate, and the extension of the Issue Mandate by the addition thereto any Shares repurchased under the Repurchase Mandate.

2. PROPOSED RE-ELECTION OF RETIRING DIRECTORS

As at the Latest Practicable Date, Mr. CHAN Yuk Ming, Mr. CHEN Yunan and Mr. CHEN Minwen are the executive Directors. Mr. FONG Wo, Felix, Mr. KWOK Chi Sun, Vincent and Mr. CHENG King Hoi, Andrew are the independent non-executive Directors.

Pursuant to Article 16.18 of the Articles of Association, Mr. Chen Minwen and Mr. Kwok Chi Sun, Vincent shall retire from the office by rotation at the Annual General Meeting. Mr. Chen Minwen, being eligible, will offer himself for re-election. The Board has been informed by Mr. Kwok Chi Sun, Vincent that he will not offer for re-election as an independent non-executive Director at the Annual General Meeting.

Mr. Kwok Chi Sun, Vincent has confirmed that there is no disagreement with the Board and there are no matters relating to their retirement that need to be brought to the attention of the Shareholders or the Stock Exchange. The Board would also like to take this opportunity to express its sincere gratitude to Mr. Kwok Chi Sun, Vincent for his valuable contributions to the Company.

Biographical details of Mr. Chen Minwen are set out in Appendix I to this circular.

3. PROPOSED ELECTION OF NEW DIRECTOR

The Board proposes that Mr. Ng Wing Fai be elected as independent non-executive Director at the Annual General Meeting.

Biographical details of Mr. Ng are set out in Appendix I to this circular.

4. PROPOSED GENERAL MANDATES TO REPURCHASE ITS OWN SHARES AND TO ISSUE NEW SHARES

At the annual general meeting of the Company held on 9 June 2015, the Company granted general mandates to the Directors enabling them to (i) repurchase Shares on the Stock Exchange; and (ii) allot, issue and deal with additional Shares. Such general mandates will lapse at the conclusion of the Annual General Meeting.

In order to give the Company the flexibility to repurchase and issue Shares if and when appropriate, the following ordinary resolutions will be proposed at the Annual General Meeting to grant new general mandates to the Directors:

- (a) to exercise all the powers of the Company to repurchase Shares on the Stock Exchange of not exceeding 10% of the total number of issued Shares as at the date of passing of the proposed ordinary resolution contained in item 6 of the notice of the Annual General Meeting. As at the Latest Practicable Date, the number of Shares in issue of the Company was 948,825,763 Shares. Subject to the passing of the proposed ordinary resolution approving the granting of the Repurchase Mandate and on the basis that no further Shares are issued or repurchased prior to the Annual General Meeting, the Company would be allowed to repurchase up to a maximum of 94,882,576 Shares under the Repurchase Mandate. The Repurchase Mandate if

approved by the Shareholders, will end on the earliest of the conclusion of the next annual general meeting of the Company, the expiration of the period within which the next annual general meeting of the Company is required by the Articles of Association or any applicable laws and regulations of the Cayman Islands to be held or the passing of an ordinary resolution of the Shareholders in general meeting revoking or varying such mandate;

- (b) to exercise all the powers of the Company to allot, issue and deal with additional Shares of not exceeding 20% of the total number of issued Shares as at the date of passing of the proposed ordinary resolution contained in item 5 of the notice of the Annual General Meeting. The Issue Mandate if approved by the Shareholders, will end on the earliest of the conclusion of the next annual general meeting of the Company, the expiration of the period within which the next annual general meeting of the Company is required by the Articles of Association or any applicable laws and regulations of the Cayman Islands to be held or the passing of an ordinary resolution of the Shareholders in general meeting revoking or varying such mandate. Based on 948,825,763 Shares in issue as at the Latest Practicable Date and assuming no further Shares will be issued or repurchased prior to the date of the Annual General Meeting, the Directors will be authorized to issue up to 189,765,152 Shares under the Issue Mandate; and
- (c) subject to the passing of the aforesaid ordinary resolutions in respect of the Repurchase Mandate and the Issue Mandate, to extend the Issue Mandate by the addition of the number of Shares repurchased by the Company under the Repurchase Mandate.

In accordance with the requirements of the Listing Rules, the Company is required to send to the Shareholders an explanatory statement containing all the information reasonably necessary to enable them to make an informed decision on whether to vote for or against the relevant resolution for the grant of the Repurchase Mandate, which is set out in Appendix II to this circular.

5. ANNUAL GENERAL MEETING AND PROXY ARRANGEMENT

At the Annual General Meeting, resolutions will be proposed for the purpose of considering and if thought fit, approving the resolutions proposed in this circular. The notice of the Annual General Meeting is set out on pages 12 to 15 of this circular.

A form of proxy for appointing proxy to attend the Annual General Meeting is enclosed with this circular and such form of proxy is also published on the websites of Hong Kong Exchanges and Clearing Limited (www.hkexnews.hk) and of the Company (www.evergreen-intl.com). To be valid, the form of proxy must be completed and signed in accordance with the instructions printed thereon and deposited, together with the power of attorney or other authority (if any) under which it is signed or a notarially certified copy of that power of attorney or authority, at the Company's Hong Kong share registrar, Computershare Hong Kong Investor Services Limited at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not less than 48 hours before the time appointed for holding the Annual General Meeting or any adjournment thereof. the form of proxy shall not preclude you from attending and voting in person at the Annual General Meeting or at any adjourned meeting thereof if you so wish, in which case the form of proxy shall be deemed to be revoked.

6. VOTING BY POLL

Pursuant to the Articles of Association, all resolutions put forward at shareholders' meetings will be voted by poll.

After the conclusion of the Annual General Meeting, the poll results will be published on the websites of Hong Kong Exchanges and Clearing Limited (www.hkexnews.hk) and of the Company (www.evergreen-intl.com).

7. RECOMMENDATION

The Directors consider that the proposed re-election of the retiring Directors and election of new Director, granting of the Repurchase Mandate and the Issue Mandate and the extension of the Issue Mandate are in the best interests of the Company and the Shareholders as a whole. Accordingly, the Directors recommend all Shareholders to vote in favour of all the relevant resolutions to be proposed at the Annual General Meeting.

Pursuant to the Listing Rules, the details of the Director who will retire at the Annual General Meeting according to the Articles of Association and be eligible for re-election at the Annual General Meeting are provided below:

Mr. CHEN Minwen, aged 40, an executive Director

Mr. CHEN Minwen was designated as an executive Director on 12 February 2010 and is primarily responsible for sales and marketing promotion and public relations activities of the Group. Mr. Chen has not held directorships in any other public companies listed in Hong Kong or overseas in the last three years.

Mr. Chen is brother of Mr. CHAN Yuk Ming, an executive Director and the chairman of the Board, Mr. CHEN Yunan, an executive Director and Ms. CHEN Mianna, a purchasing director of the Group. He is also an uncle of Ms. CHEN Yanxia, a operation director of TESTANTIN. Save as disclosed above, Mr. Chen does not have any relationships with any other Directors, senior management, substantial shareholders (as defined in the Listing Rules) or controlling shareholders (as defined in the Listing Rules) of the Company. Mr. Chen is holding positions in other members of the Group: director of each of Guangdong Evergreen Garment Co., Ltd. (長興(廣東)服飾有限公司), Guangzhou Changyue Trading Co., Ltd. (廣州市長越貿易有限公司) and Guangzhou Changzhuxing Trading Co., Ltd. (廣州市長珠興貿易有限公司).

In accordance with the meaning of Part XV of the SFO, as at the Latest Practicable Date, Mr. Chen has deemed interests in 483,934,814 Shares which were held by Pacific Success Holdings Limited, a company wholly-owned by Evisu (PTC) Limited, the trustee of a discretionary trust of which Mr. Chen is a beneficiary. On 23 January 2015, Mr. Chen was granted share options which entitle to subscribe for a total of 6,000,000 new Shares under the Share Option Scheme. Details of the said granting of share options were set out in the Company's announcement dated 23 January 2015. Save as disclosed above, he does not have any other interests in Shares within the meaning of Part XV of the SFO.

Mr. Chen entered into a service agreement with the Company for a term of three years commencing from the Listing Date, which was renewed for three years commencing from 28 November 2013 and is subject to retirement by rotation and re-election at the annual general meeting of the Company under the Articles of Association. He is entitled to an annual remuneration of HK\$2,160,000 and a year-end bonus of such amount to be determined by the remuneration committee of the Company (the "Remuneration Committee"). The remuneration shall be subject to annual review by the Board and/or the Remuneration Committee by reference to his duties and responsibilities with the Company, and to be decided by the Board. The emolument of Mr. Chen for the year from 1 January 2015 to 31 December 2015 was RMB2,543,000 (equivalent to approximately HK\$3,136,000).

Save as disclosed above, there is no information which is required to be disclosed nor is Mr. Chen involved in any of the matters required to be disclosed pursuant to any of the requirements under Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules and there are no other matters concerning Mr. Chen that need to be brought to the attention of the Shareholders.

The details of Mr. Ng Wing Fai proposed to be elected as an independent non-executive Director at the Annual General Meeting, are set out below:

Mr. Ng Wing Fai, aged 57, has over 16 years of experience in audit, taxation and consultancy in government and non-government institutes. Mr. Ng holds a bachelor's of arts degree in accountancy and a master's degree of arts in international accounting from City University of Hong Kong. He also holds a bachelor's degree with Honour in UK and Hong Kong law from The Manchester Metropolitan University. He is a fellow member of the Hong Kong Institute of Certified Public Accountants, a fellow member of the Institute of Chartered Accountants in England and Wales, a past president of the Society of Chinese Accountants & Auditors (2011), and a member of the Hong Kong Securities Institute.

Mr. Ng is an independent non-executive director of China Automation Group Limited (stock code: 569) since June 2007, a company listed on the main board of the Stock Exchange. Save as disclosed, Mr. Ng has not held directorship in any other public companies listed in Hong Kong or overseas in the last three years.

Mr. Ng does not have any relationship with any Directors, senior management, substantial shareholders (as defined in the Listing Rules) or controlling shareholders (as defined in the Listing Rules) of the Company. As at the Latest Practicable Date, Mr. Ng did not have any interests in Shares within the meaning of Part XV of the SFO.

If Mr. Ng is to be elected as an independent non-executive Director at the Annual General Meeting, Mr. Ng will enter into a service agreement with the Company for a term of two years commencing from the date of appointment as an independent non-executive Director, which can be terminated by either party giving to the other 3-months' prior written notice. Mr. Ng is subject to retirement by rotation and re-election at the annual general meeting of the Company under the Articles of Association. The amount of emoluments for Mr. Ng will be determined by the Board according to the market practice.

The Company has received from Mr. Ng his confirmation of independence pursuant to Rule 3.13 of the Listing Rules and therefore, the Board considers that he is independent and believes he should be elected as an independent non-executive Director.

Save as disclosed above, there is no information which is required to be disclosed nor is Mr. Ng involved in any of the matters required to be disclosed pursuant to any of the requirements under Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules and there are no other matters concerning Mr. Ng that need to be brought to the attention of the Shareholders.

This Appendix serves as an explanatory statement, as required by the Listing Rules, to provide requisite information to you for your consideration of the Repurchase Mandate.

1. LISTING RULES

The Listing Rules permit companies whose primary listings are on the Stock Exchange to repurchase their own shares on the Stock Exchange subject to certain restrictions, the most important of which are summarised below.

2. SHAREHOLDERS' APPROVAL

All proposed repurchases of shares on the Stock Exchange by a company with its primary listing on the Stock Exchange must be approved in advance by an ordinary resolution, either by way of a general mandate or by a specific approval.

3. REASONS FOR THE REPURCHASE

The Directors believe that the Repurchase Mandate affords the Company the flexibility and ability in pursuing the best interests of the Company and its Shareholders. An exercise of the Repurchase Mandate may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share and will only be made when the Directors believe that a repurchase will benefit the Company and its Shareholders.

4. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 948,825,763 Shares.

Subject to the passing of the resolution for the grant of the Repurchase Mandate (resolution no. 6 as set out in the notice of the Annual General Meeting contained in this circular) and on the basis that no further Shares are issued or repurchased by the Company prior to the Annual General Meeting, the Company will be allowed under the Repurchase Mandate to repurchase, during the period in which the Repurchase Mandate remains in force, up to a maximum of 94,882,576 Shares, representing 10% of the total number of issued Shares as at the date of the Annual General Meeting.

5. FUNDING OF REPURCHASES

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its memorandum of association and Articles of Association, the Listing Rules, the laws of the Cayman Islands and any other applicable laws.

The Company is empowered by its Articles of Association to repurchase Shares. The laws of the Cayman Islands provide that the amount paid in connection with a share repurchase by a company may only be paid out of either the profits of the company or out of the proceeds of a fresh issue of shares made for such purpose or, subject to the Articles of Association and the provisions of the Cayman Islands laws, out of capital.

Taking into account the current working capital position of the Company, the Directors consider that, if the Repurchase Mandate was to be exercised in full, it might have a material adverse effect on the working capital and/or the gearing position of the Company as compared with the position as at 31 December 2015, the date to which the last audited accounts of the Company were made up. However, the Directors do not intend to make any repurchases to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements or the gearing position of the Company which in the opinion of the Directors are from time to time appropriate for the Company.

6. MARKET PRICES OF SHARES

7. UNDERTAKING OF THE DIRECTORS

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the powers of the Company to make purchases under the Repurchase Mandate and in accordance with the Listing Rules and the laws of the Cayman Islands.

8. EFFECTS OF TAKEOVERS CODE

If as a result of a repurchase of Shares by the Company pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purposes of the Takeovers Code. Accordingly, a Shareholder or a group of Shareholders acting in concert

(within the meaning under the Takeovers Code), depending on the level of increase in its or their shareholding, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, to the best knowledge and belief of the Directors, each of Mr. CHAN Yuk Ming (founder of the discretionary trust), Mr. CHEN Yunan and Mr. CHEN Minwen (beneficiaries of the discretionary trust) and Evisu (PTC) Limited (trustee of the discretionary trust) was deemed to be interested in 483,934,814 Shares representing approximately 51.00% of the issued share capital of the Company within the meaning of Part XV of the SFO. Mr. CHAN Yuk Ming was further interested in 1,736,000 Shares representing approximately 0.18% of the issued share capital of the Company, while Ms. CHEN Mianna was interested in 45,543,636 Shares representing approximately 4.80% of the issued share capital of the Company. In the event that the Repurchase Mandate is exercised in full and if there is no change in issued share capital of the Company, the aggregate interests of Mr. CHAN Yuk Ming, Mr. CHEN Yunan, Mr. CHEN Minwen and Ms. CHEN Mianna would be increased to approximately 62.21% of the issued share capital of the Company.

Based on the information known as at the Latest Practicable Date, the Directors are not aware of any consequences which may give rise to an obligation to make a mandatory offer under Rule 26 of the Takeovers Code. Nevertheless, the Directors do not intend to exercise the Repurchase Mandate to such extent as would, in the circumstances, trigger any potential consequences under the Takeovers Code.

The Directors have no present intention to repurchase Shares to such extent which will result in the aggregate number of Shares held by the public shareholders falling below the prescribed minimum percentage required by the Stock Exchange.

9. DISCLOSURE OF INTERESTS

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, any of their respective close associates (as defined in the Listing Rules) have any present intention to sell their Shares to the Company under the Repurchase Mandate in the event that the granting of the Repurchase Mandate is approved by the Shareholders.

The Company has not been notified by any core connected persons (as defined in the Listing Rules) of the Company that they have a present intention to sell any Shares to the Company, or that they have undertaken not to sell any Shares held by them to the Company in the event that the granting of the Repurchase Mandate is approved by the Shareholders.

10. REPURCHASE OF SHARES MADE BY THE COMPANY

No purchase of Shares has been made by the Company in the six months preceding to the Latest Practicable Date (whether on the Stock Exchange or otherwise).

NOTICE IS HEREBY GIVEN that an Annual General Meeting (“AGM”) of Evergreen International Holdings Limited (the “Company”) will be held at Kowloon Room I, Mezzanine Floor, Kowloon Shangri-La, 64 Mody Road, Tsim Sha Tsui East, Kowloon, Hong Kong on Tuesday, 7 June 2016 at 11:00 a.m. for the following purposes:

1. To receive and consider the audited consolidated financial statements and the reports of the directors of the Company (the “Directors”) and of the auditors of the Company for the year ended 31 December 2015;
2. To re-elect the retiring Director and to authorize the board of Directors (the “Board”) to fix the respective Directors’ remuneration;
3. To elect Mr. Ng Wing Fai as an independent non-executive Director and to authorize the Board to fix his remuneration;
4. To re-appoint auditors and to authorize the Board to fix their remuneration;
5. To consider and, if thought fit, pass with or without amendments, the following resolution as an ordinary resolution:

“THAT:

- (a) subject to sub-paragraph (c) of this resolution and pursuant to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) (the “Listing Rules”) as amended from time to time, the exercise by the Directors during the Relevant Period (as defined below) of all the powers of the Company to allot, issue and deal with additional shares of the Company (the “Shares”) and to make or grant offers, agreements and options, including warrants to subscribe for Shares, which might require the exercise of such powers be and the same is hereby generally and unconditionally approved;
- (b) the approval in sub-paragraph (a) of this resolution shall authorize the Directors during the Relevant Period to make or grant offers, agreements and options which might require the exercise of such powers after the end of the Relevant Period;

(c) the aggregate number of Shares allotted or agreed conditionally or unconditionally to be allotted (whether pursuant to an option or otherwise) and issued by the Directors pursuant to the approval in sub-paragraph (a) of this resolution, otherwise than pursuant to (i) a Rights Issue (as defined below); or (ii) any issue of Shares upon the exercise of rights of subscription or conversion under the terms of any warrants issued by the Company or any securities which are convertible into Shares; or (iii) the exercise of any options granted under the share option scheme of the Company; or (iv) any scrip dividend or similar arrangement providing for the allotment and issue of Shares in lieu of the whole or part of the dividend on Shares in accordance with the memorandum and articles of association of the Company (the “Articles”) shall not exceed 20% of the total number of issued Shares as at the date of passing of this resolution and the said approval shall be limited accordingly; and

(d) for the purposes of this resolution:

“**Relevant Period**” means the period from the date of the passing of this resolution, until whichever is the earliest of:

- (i) the conclusion of the next annual general meeting of the Company;
- (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles or any applicable laws and regulations of the Cayman Islands to be held; and
- (iii) the date on which the authority set out in this resolution is revoked or varied by the passing of an ordinary resolution of the shareholders of the Company (the “Shareholders”) in general meeting.

“**Rights Issue**” means an offer of Shares, or offer or issue of warrants, options or other securities of the Company giving rights to subscribe for Shares, open for a period fixed by the Directors to holders of Shares or any class thereof on the register on a fixed record date in proportion to their then holdings of such Shares or class thereof (subject to such exclusion or other arrangements as the Directors may deem necessary or expedient in relation to fractional entitlements or having regard to any restrictions or obligations under the laws of, or the requirements of any recognised regulatory body or any stock exchange in, any territory applicable to the Company).”;

6. To consider and, if thought fit, pass with or without amendments, the following resolution as an ordinary resolution:

“**THAT:**

- (a) subject to sub-paragraph (b) of this resolution, the exercise by the Directors during the Relevant Period (as hereinafter defined) of all the powers of the Company to repurchase Shares on the Stock Exchange or any other exchange on which the Shares may be listed and recognised for this purpose by the Securities

and Futures Commission of Hong Kong and the Stock Exchange under the Codes on Takeovers and Mergers and Share Buy-backs (the “Recognised Stock Exchange”) subject to and in accordance with all applicable laws and the requirements of the Listing Rules or that of any other Recognised Stock Exchange, be and the same is hereby generally and unconditionally approved;

- (b) the total number of Shares which may be purchased by the Company pursuant to the approval in sub-paragraph (a) of this resolution during the Relevant Period shall not exceed 10% of the total number of issued Shares as at the date of passing of this resolution and the said approval shall be limited accordingly; and
- (c) for the purpose of this resolution:

“**Relevant Period**” means the period from the date of the passing of this resolution, until whichever is the earliest of:

- (i) the conclusion of the next annual general meeting of the Company;
 - (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles or any applicable laws and regulations of the Cayman Islands to be held; and
 - (iii) the date on which the authority set out in this resolution is revoked or varied by the passing of an ordinary resolution of the Shareholders in general meeting.”; and
7. To consider and, if thought fit, pass with or without amendments, the following resolution as an ordinary resolution:

“**THAT** conditional upon resolution nos. 5 and 6 above being passed, the number of Shares which are repurchased by the Company under the authority granted to the Directors as mentioned in the resolution no. 6 above shall be added to the aggregate number of Shares that may be allotted or agreed conditionally or unconditionally to be allotted and issued by the Directors under the authority granted pursuant to resolution no. 5 above, provided that the number of Shares repurchased by the Company shall not exceed 10% of the total number of issued Shares as at the date of passing of this resolution.”
