- To be valid, this Form of Proxy, together with any power of attorney or other authority (if any) under which it is signed or a notarially curfified copy of such power of attorney or other authority must be deposited at the Company's Hong Kong Branch Share Registrar, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not less than 48 hours before the time appointed for holding the SGM or any adjournment thereof. Any alterations made in this Form of Proxy must be initialled by the person who signs it. 7

Completion and delivery of this Form of Proxy will not preclude you from attending and voting at the SGM if you so wish. The Chairman will demand a poll on each of the resolutions submitted for determination at the SGM. On a poll, every member present in person or by a duly authorised corporate representative or by proxy shall have one vote for every share held by him. The results of the poll will be published on the websites of the Company and The Stock Exchange of Hong Kong Limited as soon as possible, but in any event not later than the commencement of the morning trading session on the next business day following the SGM. 10.
