### First Pacific Company Limited (the "Company")

- New Arrangements on Dissemination of Corporate Communications

### ARRANGEMENTS

#### 1. Corporate Communications

A notice of publication of the Website Version<sup>5</sup> of Corporate Communications, in both English and Chinese, will be sent by the Company to Shareholders by email or by post (if the Company does not possess the functional email address of a Shareholder) on or after the publication date of the Corporate Communications (as the case may be).

The Company will arrange for printed version(s) of future Corporate Communications to be mailed to the relevant Shareholders in their preferred language(s) if they have made an election to receive printed versions.

For the avoidance of doubt, non-registered Shareholders will not receive any Actionable Corporate Communications<sup>6</sup> published by the Company.

### 2. Provision of Electronic Contact Details

As a non-registered Shareholder, if you wish to receive Corporate Communications from the Company pursuant to the Listing Rules, you should liaise with your banks, brokers, custodians, nominees or HKSCC Nominees Limited through which your shares are held (collectively, the "Intermediaries") and provide your address or email address to your Intermediaries.
