CONNECTED TRANSACTION ACQUISITION OF THE TARGET TRADEMARKS

The Board announces that on 15 August 2011, the Company and YTO entered into the Trademarks Transfer Agreement, pursuant to which the Company has agreed to purchase the Target Trademarks from YTO at a total consideration of RMB59,501,000 (equivalent to approximately HK\$71,401,200).

YTO is the controlling shareholder of the Company and therefore is a connected person of the Company. Accordingly, the transaction contemplated under the Trademarks Transfer Agreement constitutes a connected transaction of the Company under Chapter 14A of the Listing Rules.

Since the applicable percentage ratios are less than 5%, the Trademarks Transfer Agreement is subject to the reporting and announcement requirements only but exempt from the independent shareholders' approval requirement pursuant to Rule 14A.32 of the Listing Rules.

INTRODUCTION

The Board announces that on 15 August 2011, the Company and YTO entered into the Trademarks Transfer Agreement, pursuant to which the Company has agreed to purchase the Target Trademarks from YTO at a total consideration of RMB59,501,000 (equivalent to approximately HK\$71,401,200).

Set out below is a summary of the principal terms of the Trademarks Transfer Agreement:

TRADEMARKS TRANSFER AGREEMENT

Parties

- (1) The Company, as purchaser
- (2) YTO, as vendor

Assets to be acquired

Pursuant to the Trademarks Transfer Agreement, the Company has agreed to purchase from YTO a total of 45 PRC Target Trademarks, details of which are set out in the paragraph headed "INFORMATION OF THE TARGET TRADEMARKS" below.

Consideration and payment terms

13 Target Trademarks A were transferred at a total consideration of RMB59,501,000 (equivalent to approximately HK\$71,401,200), while 32 Target Trademarks B were transferred at nil consideration. The above considerations were determined by the parties with reference to the total appraised value of the Target Trademarks A, the appreciation of value of the Target Trademarks A attributable to the Company's business, as well as the frequency of use and commercial value of the Target Trademarks B (further details are set out in the paragraph headed "BASIS OF THE CONSIDERATION" below).

The consideration under the Trademarks Transfer Agreement shall be paid by the Company to YTO in accordance with the following manners:

- (i) 30% of the consideration, being RMB17,850,300, be paid to YTO within 30 working days upon the effective date of the agreement;
- (ii) 30% of the consideration, being RMB17,850,300, be paid to YTO within 30 working days after the Trademarks Transfer Gazette Date; and
- (iii) the balance of the consideration, being RMB23,800,400, be paid to YTO within 1 year upon the effective date of the agreement.

The Company intends to satisfy the above consideration in cash from its internal resources.

Conditions precedent

The Trademarks Transfer Agreement shall take effect upon approval of the agreement at the Board meeting of the Company and at the general meeting of YTO.

Completion

Transfer of the Target Trademarks shall complete on the Trademarks Transfer Gazette Date while completion of the Trademarks Transfer Agreement shall take place upon completion of the transfer of the Target Trademarks and full payment of the consideration by the Company.

BASIS OF THE CONSIDERATION

The consideration of the Trademarks Transfer Agreement was determined after arm's length negotiations between the Company and YTO with reference to the following factors:

(i) With respect to the Target Trademarks A, their appraised values in total, being RMB457,700,000, as at 31 December 2010, which were prepared by Zhonghe Appraisal Co., Ltd.* (中和資產評估有限公司), a PRC independent professional valuer, by using the income approach (收益法).

There is a substantial discount of RMB398,199,000 when comparing the consideration of the Target Trademarks A of RMB59,501,000 with the above appraised value of RMB457,700,000, which was mainly attributable to the huge contribution by the Company on the Target Trademarks A through its intense promotion and wide use of the Target Trademarks A on its products over the past years. According to the analytical report in respect of the past contribution on the Target Trademarks A by the Company and YTO prepared by TX Investment Consulting Co., Ltd.* (天相投資顧問有限公司), a PRC independent financial adviser, the contribution value on the Target Trademarks A by YTO was RMB59,501,000.

(ii) With respect to the Target Trademarks B, taking into account (a) the little commercial value of the Target Trademarks B due to non use or little use of such trademarks, and (b) the mere safeguarding purpose of such trademarks, YTO has agreed to transfer the Target Trademarks B to the Company at nil consideration.

In view of the foregoing, the Directors (including the independent non-executive Directors) consider that the consideration of the Trademarks Transfer Agreement is fair and reasonable and in the interests of the Company and the Shareholders as a whole.

EFFECTS OF THE ACQUISITION

Prior to the signing of the Trademarks Transfer Agreement, YTO has granted licenses to the Group and certain third parties to use the Target Trademarks. The said licenses are non-exclusive and regionally unrestricted licenses. Pursuant to the Trademarks Transfer Agreement, the license agreements entered into between the Company and YTO involving the Target Trademarks shall automatically lapse upon completion of the Trademarks Transfer Agreement.

YTO has undertaken to procure the above third parties, who were licensed to use the Target Trademarks, not to conduct business which competes or may compete with the business of the Group. The validity of the licenses granted by YTO to the above third parties will not be affected by the Acquisition. Upon request by the Company, YTO shall procure the above third parties, being the licensees, to friendly negotiate with the Company for amendments to those license agreements and if necessary, entering into supplemental agreements and/or new license agreements with the Company.

Pursuant to the Trademarks Transfer Agreement, the Company has agreed, after completion of the Acquisition, to grant license(s) to YTO and its subsidiaries to use the Target Trademarks at a fair price in light of YTO's production and operation needs, provided that the use of those Target Trademarks shall not compete or likely to compete with the business of the Group and shall not have any adverse effect on any of the Target Trademarks. The Company will make further announcement(s) with respect to the above potential transaction(s), if any, in accordance with the relevant provisions of the Listing Rules as and when appropriate.

REASONS FOR THE ACQUISITION

Currently, the Group has been using the Target Trademarks under the trademark license agreements entered into between the Company and YTO. The said trademark license agreements have granted the Company the pre-emptive rights to obtain license of and to acquire the Target Trademarks. Considering that most of the Group's products are using the Target Trademarks, and that the mark "** *** in the Target Trademarks is the earliest mark being recognized as a "PRC Well-known Trademark" in the PRC agricultural machinery industry and therefore is a representative brand in the PRC agricultural machinery industry and has been enjoying the relatively high reputation and great renown and deep influence in the PRC market and industry, the Board believes that the Acquisition will (i) help to save the annual trademark license fees paid to YTO in respect of the Target Trademarks; (ii) after obtaining the ownership of the Target Trademarks, fundamentally strengthen the legal stability towards the related interests enjoyed by the Company (being the owner) over the Target Trademarks; (iii) enhance the Company's assets comprehensiveness; and (iv) enable the Company to make full use of the influence and rallying point of the Target Trademarks in the market, thereby further encouraging its market expansion.

In view of the above, the Directors believe that the Acquisition will benefit the Company and the Group in terms of business development and costs control in the long run.

The terms of the Trademarks Transfer Agreement were determined after arm's length negotiations between the Company and YTO. The Directors (including the independent non-executive Directors) consider that the Trademarks Transfer Agreement was entered into in the ordinary course of business and on normal commercial terms and the respective terms thereof are fair and reasonable and in the interests of the Company and the Shareholders as a whole.

INFORMATION OF THE GROUP AND YTO

The Group is principally engaged in production and sale of agricultural machineries, power machineries and agricultural construction machineries. The principal products include tractors of hi-powered, mid-powered and low-powered, excavators, diesel engines and other accessories of tractors, forklift trucks and mining trucks, etc.

YTO is the controlling shareholder of the Company, holding 443,910,000 or 52.48% of the voting Shares of the Company, and is principally engaged in production of transporting machineries, casting parts, vehicles products and components.

RELATIONSHIP BETWEEN PARTIES AND LISTING RULES IMPLICATIONS

As mentioned above, YTO is the controlling shareholder of the Company and therefore is a connected person of the Company. Accordingly, the transaction contemplated under the Trademarks Transfer Agreement constitutes a connected transaction of the Company under Chapter 14A of the Listing Rules.

Since the applicable percentage ratios are less than 5%, the Trademarks Transfer Agreement is subject to the reporting and announcement requirements only but exempt from the independent shareholders' approval requirement pursuant to Rule 14A.32 of the Listing Rules.

Mr. Zhao Yanshui, the executive Director of the Company, as well as Mr. Su Weike and Mr. Yan Linjiao, the non-executive Directors of the Company, are the directors of YTO. At the same time, Ms. Dong Jianhong and Mr. Qu Dawei, the executive Directors of the Company, as well as Mr. Liu Yongle and Mr. Li Youji, the non-executive Directors of the Company, are all senior management of YTO. Mr. Zhao, Mr. Su, Mr. Yan, Ms. Dong, Mr. Qu, Mr. Liu and Mr. Li have therefore abstained from voting on the Board resolutions approving the Trademarks Transfer Agreement.
