# 1. Property Sales in August 2012

In August 2012, the Group recorded property sales of RMB 1.1 billion, representing a month-on-month decrease of 4.7%. The total property sold area was 112,154 sq.m., representing a month-on-month decrease of 20.4%. From January to August, the total property sales and property sold area amounted to RMB 7.8 billion and 921,165 sq.m.

In August, Northeast China recorded the highest sales amount of RMB 423.6 million, increased by 32.5% month-on-month.
