On 14 July 2015, the Company entered into the fees settlement agreement with the legal adviser of the Company, Simon Ho & Co., Solicitors (“Legal Adviser”), pursuant to which the Company has agreed with the Legal Adviser to settle the outstanding professional fees of HK\$2,048,000 by the issuance and allotment of 6,714,754 remuneration shares to Mr. Wong Vai Nang at an issue price of approximately HK\$0.305 per remuneration share. For details, please refer to the Company’s announcements dated 14 July 2015 and 22 July 2015.

2. On 14 July 2015, the Company and Thrive Season Limited (“Thrive Season”) entered into the loan settlement agreement, pursuant to which Thrive Season has conditionally agreed to subscribe for and the Company has conditionally agreed to allot and issue 23,461,177 settlement shares at the issue price of approximately HK\$0.305 per settlement share for full repayment of the final indebted amount due to Thrive Season on and subject to the terms and conditions of the loan settlement agreement.
