Remarks (if any):

1. On 21 January 2021, the Company held a special general meeting and a special resolution was passed, approving the capital reorganisation by which the issued share capital of the Company was reduced to HK\$2,449,554.13 divided into 244,955,413 consolidated shares of par value of HK\$0.01 each with effect from 25 January 2021. For details of the capital reorganisation, please refer to the announcements of the Company dated 17 November 2020 and 21 January 2021, the circular of the Company dated 14 December 2020 and the Next Day Disclosure Return of the Company dated 25 January 2021.

2. The Company has issued convertible bonds in an aggregate principal amount of HK\$112,320,000 on 22 February 2019. Details were set out in the announcements of the Company dated 16 November 2018, 22 January 2019, 14 February 2019 and 22 February 2019 and the circular of the Company dated 25 January 2019.

3. As a result of the aforesaid capital reorganisation, the conversion price of the existing convertible bond was adjusted from HK\$0.123 per existing share to HK\$1.23 per new share and the maximum number of new shares to be issued by the Company upon conversion of the existing convertible bond in full was adjusted to 91,317,073 new shares with effect from 25 January 2021.
