1. The Company has issued convertible bonds in an aggregate principal amount of HK\$99,757,011 with conversion price of HK\$0.8 per share on 21 February 2021. Moreover, the conversion rights under the convertible bonds were extinguished pursuant to its terms on 22 August 2022. Details were set out in the announcement of the Company dated 12 August 2022.
