On, 19 June 2014, the Company has proposed (i) to subdivide each (1) existing issued and unissued
shares of HK\$0.01 in the share capital of the Company into eight (8) subdivided shares of HK\$0.00125
each; and (ii) to raise approximately HK\$384 million (before expenses) by way of rights issue of
2,400,000,000 rights shares at the subscription price of HK\$0.16 per rights share on the basis of one
rights share for every subdivided share held on 11 August 2014. The rights issue is only available to the
qualifying shareholders and such qualifying shareholders are not entitled to apply for any rights share
which are in excess of their assured entitlements. For details, please refer to the Company
