- (b) immediately following the Capital Reduction becoming effective, each of the authorised but unissued Consolidated Shares of par value of HK\$0.04 each be subdivided (the "Share Subdivision") into four (4) unissued new shares of par value of HK\$0.01 each (the "New Shares"), and such New Shares shall rank pari passu in all respects with each other and have the rights and privileges and be subject to the restrictions in respect of ordinary shares contained in the memorandum and articles of association of the Company;
- (c) immediately following the Capital Reduction and the Share Sub-division, the authorised share capital of the Company be changed from HK\$20,000,000 divided into 500,000,000 Consolidated Shares to HK\$20,000,000 divided into 2,000,000,000 New Shares;

- 1. Any member of the Company entitled to attend and vote at the EGM shall be entitled to appoint another person as his/ her proxy to attend and vote instead of him/her.
