Commence Construction in Succession

22 October 2018, Hong Kong - China Everbright Greentech Limited ("Everbright Greentech" or the

"Company") (HKSE: 01257) is pleased to announce that the Company has recently seen four projects

commence construction in succession, including Shandong Weihai Wendeng Biomass Electricity and Heat

Cogeneration Project ("Weihai Project"), Henan Xiayi Integrated Biomass and Waste-to-Energy Projects ("Xiayi

Project") and Jiangsu Environmental Remediation Project Phase II ("Jiangsu Project Phase II"). All of the

projects have been progressing smoothly.

Weihai Project, which commands an investment of approximately RMB330 million, has an annual designed

biomass raw materials processing capacity of 300,000 tonnes, and is expected to generate green electricity of

approximately 180,000,000 kWh annually. The project is estimated to complete construction and commence

operation in the second half of 2019.

Xiayi Project, which commands an investment of approximately RMB560 million, has an annual designed

biomass raw materials processing capacity of 250,000 tonnes and a designed daily household waste

processing capacity of 350 tonnes. The project is expected to generate green electricity of approximately

240,000,000 kWh annually. It is estimated to complete construction and commence operation in the first half

of 2020.

Jiangsu Project Phase II involves a contract value of RMB44.89 million. The remediation work of the

contaminated sites is expected to be completed in the first half of 2019.
