

EVERBRIGHT GREENTECH COMPLETES ISSUANCE OF 2023 SECOND TRANCHE GREEN MEDIUM-TERM NOTE

Hong Kong, 25 September 2023 – China Everbright Greentech Limited ("Everbright Greentech", or the "Company") (SEHK: 1257.HK) is pleased to announce that the Company recently completed the issuance of the second tranche of the 2023 green medium-term note (the "MTN") (the "2023 Second Tranche Green MTN") in the PRC, with an issue size of RMB1 billion. The interest commencement date is 22 September 2023, and the base term is two years, with a fixed interest rate of 2.83% per annumand a subscription rate of 2.86 times. The proceeds will be used for repayment of the Company's interest-bearing debts, replenishment of the Company's working capital and/or investment in and construction of the Company's environmental protection projects and for other business development purposes. Everbright Securities Company Limited acted as the lead underwriter and China Construction Bank Corporation and Bank of Ningbo Co., Ltd. acted as the joint lead underwriters for the 2023 Second Tranche Green MTN which was publicly offered on the national interbank bond market.

In April 2023, the Company received notice of acceptance of registration from the National Association of Financial Market Institutional Investors (NAFMII) in respect of the registration and issuance of multiple types of debt financing instruments in an aggregate amount of not more than RMB5 billion in one or more tranches to institutional investors in the national inter-bank bond market of the PRC. On 15 May 2023, the Company completed the issuance of the first tranche of the 2023 green medium-term note.

Mr. Qian Xiaodong, CEO of Everbright Greentech, said, "Over the recent years, Everbright Greentech has achieved remarkable progress in diversifying its financing channels, as evidenced by the successful issuances of the Company's first asset-backed notes, which use receivables relating to the national subsidies for renewable energy power prices, the nation's first green MTN relating to carbon-neutral and rural revitalisation, and the perpetual MTN, effectively mobilising the capital market and providing consistent and flexible funding support for the Company's operating activities. The issuance of the 2023 Second Tranche Green MTN not only capitalised on the relatively low market interest rates, but also served as an update to bond investors on the Company's development vision, strategic layout, business operations and sound creditworthiness. The extensive attention from investors reflected the market's trust in the Company. At this key stage in the Company's transformation and growth, Everbright Greentech will continue to diversify its financing channels to support the Company's transition."
