In August 2012, Greentown Group launched a total of 8 new projects or phases of projects, with total saleable area of approximately 100,000 sqm.

In August 2012, Greentown Group recorded total sales of 1,363 units, with total saleable area of approximately 224,000 sqm. Monthly sales amounted to approximately RMB4.4 billion. For the 8 months ended 31 August 2012, Greentown Group achieved a YTD sales of approximately RMB30 billion (including RMB2.8 billion agreement sales), of which approximately RMB16.39 billion was attributable to the Group.

New Projects Acquired during the Month

Tongxiang Yada International Health Ecological Park Project is located in Bai Ma Dun Village, Wuzhen Town, Tongxiang City, Zhejiang Province. The land will be developed mainly for residential purposes with a total site area of approximately 233,000 sqm, and a planned above-ground GFA of approximately 156,000 sqm. Total land cost was approximately RMB 190 million. The project will be developed under the theme of "retirement-property project". The land was acquired through auction in the open market and the Group owns 50% equity interest in the project.
