In April 2013, Greentown Group recorded total sales of 1,514 units, with total saleable area of approximately 260,000 sqm. Monthly sales amounted to approximately RMB5.6 billion.

For the 4 months ended 30 April 2013, Greentown Group recorded a total saleable area of 840,000 sqm, and achieved total contracted sales of approximately RMB17.9 billion, representing a YoY increase of 128%, of which approximately RMB9.3 billion was attributable to the Group. As of 30 April 2013, Greentown Group recorded agreement sales of RMB3.8 billion. of which approximately RMB1.8 billion was attributable to the Group.
