Pre-sales Overview

In December 2020, the Greentown Group (including Greentown China Holdings Limited and its subsidiaries, together with its joint ventures and associates) launched 49 new self-investment projects in whole or in phases, with a total saleable area of approximately 1,690,000 sqm.

Greentown Group sold 13,855 units of self-investment projects with a saleable area of approximately 1,640,000 sam in December 2020. Monthly sales* reached approximately RMB44.1 billion, with an approximate average selling price of RMB26,878 per sqm. From January to December 2020, Greentown Group recorded a saleable area of approximately 8,250,000 sqm, with a contracted sales amounting to approximately RMB214.7 billion (increased by 59% year-on-year); of which approximately RMB119.4 billion was attributable to the Greentown Group. As at 31 December 2020, in addition contracted sales. Greentown Group recorded to subscription sales of RMB5.6 billion, of which approximately RMB2.9 billion was attributable to Greentown Group.

In December 2020, the total saleable area of the under Greentown Group project properties sold management business using "Greentown" brand name (non-self-investment projects, referred to as "projects under project management") achieved approximately 670,000 sgm, with a total contracted amount of approximately RMB9.3 billion. From January to December 2020, the total contracted sales of the under project projects management reached approximately RMB74.5 billion, with a total saleable area of approximately 5,600,000 sqm.

Taking into account all of the above, for the twelve months ended 31 December 2020, Greentown Group recorded a total saleable area of approximately 13,850,000 sqm, with a total contracted sales of approximately RMB289.2 billion, representing a year-onyear increase of approximately 43%.
