GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES RE-ELECTION OF DIRECTORS AND NOTICE OF ANNUAL GENERAL MEETING

INTRODUCTION

It is proposed that at the annual general meeting of GTI Holdings Limited (the "Company") for the year ended 31 December 2017, ordinary resolutions will be proposed to (i) grant to the directors of the Company (the "Directors") general mandates to issue and repurchase shares of the Company (the "Shares") and (ii) re-elect directors of the Company.

This circular contains the explanatory statement in compliance with the Rules (the "Listing Rules") Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") and gives all the information reasonably necessary to enable

Shareholders of the Company (the "Shareholders") to make an informed decision on whether to vote for or against the ordinary resolution to approve the purchase by the Company of its own shares.

GENERAL MANDATE TO ISSUE SHARES

At the annual general meeting of the Company to be held on 4 June 2018 (the "AGM"), an ordinary resolution will be proposed to grant a general mandate to the Directors to allot, issue and otherwise deal with the Shares up to 20% of the issued share capital of the Company as at the date of resolution (the "Share Issue Mandate") to provide flexibility for the Company to raise fund by way of issue of new Shares efficiently. Subject to the grant of the Share Issue Mandate and the Repurchase Mandate (as defined below), ordinary resolutions will be proposed to increase the aggregate nominal amount of the number of Shares which may be allotted and issued by the Directors under the Share Issue Mandate by an amount equivalent to the nominal amount of the number of Shares repurchased by the Company under the Repurchase Mandate (the "Extension Mandate"). As at 24 April 2018 (the "Latest Practicable Date"), being the latest practicable date for ascertaining certain information prior to the printing of this circular, there were in issue an aggregate of 5,396,730,909 Shares. If the Company exercises the Share Issue Mandate in full, on the basis that no further Shares will be issued prior to the date of the AGM, up to 1,079,346,181 new Shares will be allotted and issued by the Company.

The Share Issue Mandate authorises the Directors to allot, issue and otherwise deal with the Shares during the period from the passing of the resolution approving the Share Issue Mandate and ending on the earliest of: (a) the date of the next annual general meeting; (b) the date by which the next annual general meeting of the Company is required to be held by the articles of association of the Company or by the applicable laws; or (c) the date on which the Share Issue Mandate is revoked or varied by an ordinary resolution of the Shareholders in a general meeting of the Company.

GENERAL MANDATE TO REPURCHASE SHARES

At the AGM, an ordinary resolution will be proposed that the Directors be given a general mandate to exercise all powers of the Company to repurchase issued and fully paid Shares (the "Repurchase Mandate"). Under the Repurchase Mandate, the number of Shares that the Company may repurchase shall not exceed 10% of the issued share capital of the Company as at the date of the resolution. The Company's authority is restricted to purchases made on the Stock Exchange in accordance with the Listing Rules. If the Company exercises the Repurchase Mandate in full, on the basis that no further Shares will be issued prior to the date of the AGM, up to 539,673,090 Shares will be repurchased by the Company.

The Repurchase Mandate allows the Company to make or agree to make purchases only during the period from the passing of the resolution approving the Repurchase Mandate and ending on the earliest of: (a) the date of the next annual general meeting; (b) the date by which the next annual general meeting of the Company is required to be held by the articles of association of the Company or by the applicable laws; or (c) the date upon which the Repurchase Mandate is revoked or varied by an ordinary resolution of the Shareholders in a general meeting of the Company.

The Directors have no present intention to repurchase any Shares but consider that the Repurchase Mandate will afford the Company the flexibility to make such repurchase when appropriate and beneficial to the Company. Such repurchases may enhance the net value and/or earnings per Share. As compared with the financial position of the Company as at 31 December 2017 (being the date of its latest audited accounts), the Directors consider that

there would be a material adverse impact on the working capital and on the gearing position of the Company in the event that the proposed Repurchase Mandate is to be exercised in full during the proposed repurchase period. No purchase would be made in circumstances that could have a material adverse impact on the working capital or gearing ratio of the Company. The Company is empowered by its memorandum and articles of association to purchase its Shares. The laws of the Cayman Islands provide that the amount of capital repaid in connection with a share repurchase may only be paid out of either the profits that would otherwise be available for distribution by way of dividend or the proceeds of a new issue of shares made for such purpose.

The amount payable on repurchase may only be paid out of either the profits that would otherwise be available for distribution by way of dividend or out of the share premium of the Company. Under the laws of the Cayman Islands, the repurchased shares will remain part of the authorised but unissued share capital of the Company. The Directors intend to apply the profits that would otherwise be available for distribution by way of dividend for any purchase of the Shares.

Directors, their close associates and core connected persons

None of the Directors nor, to the best of the knowledge and belief of the Directors having made all reasonable enquiries, any of their respective close associates has any present intention, in the event that the proposed Repurchase Mandate is approved by the Shareholders, to sell Shares to the Company. No core connected person of the Company (as defined in the Listing Rules) has notified the Company that he/she has a present intention to sell Shares to the Company nor has he/she undertaken not to sell any of the Shares held by him/her to the Company in the event that the Company is authorised to make purchases of Shares.

Undertaking of the Directors

The Directors have undertaken to the Stock Exchange to exercise the power of the Company to make purchases pursuant to the proposed resolution in accordance with the Listing Rules, all applicable laws of the Cayman Islands and the regulations set out in the memorandum and articles of association of the Company (the "Articles").

Effect of Hong Kong Codes on Takeovers and Mergers and Share Buy-backs

A repurchase of Shares by the Company may result in an increase in the proportionate interests of a substantial shareholder of the Company in the voting rights of the Company, which could give rise to an obligation to make a mandatory offer in accordance with Rule 26 of the Hong Kong Codes on Takeovers and Mergers and Share Buy-backs (the "Code").

As at the Latest Practicable Date, to the best of the knowledge and belief of the Company, the Shareholders who were interested in 10% or more of the issued shares of the Company, were as follows:—

Note1: Ms. Wong Hiu Hung, spouse of Mr. Poon, held 4,000,000 shares. Gold Train (a company wholly and beneficially owned by Mr. Poon) held 3,608,000 shares. As a result, Mr. Poon were deemed to be interested in 3,817,050,000 shares by virtue of the Securities and Futures Ordinance ("SFO"). In the event that the Repurchase Mandate is to be exercised in full, the shareholding of Mr. Poon in the Company would be increased to approximately 78.59% of the issued share capital of the Company by virtue of the SFO.

Note2: China Great, having a security interest in 2,752,332,765 shares, was interested in 2,752,332,765 shares by virtue of the SFO. In the event that the Repurchase Mandate is to be exercised in full, the interest of China Great in the Company would be increased to approximately 56.67% of the issued share capital of the Company by virtue of the SFO.

Such increases would not give rise to an obligation to make a mandatory offer under Rule 26 of the Code. If as a result of the exercise of the power to repurchase Shares pursuant to the Repurchase Mandate, the number of listed Shares which are in the hands of the public falls below the prescribed minimum of 25% as required by the Stock Exchange, the Company will not exercise the power to repurchase Shares.

Listing Rules in relation to repurchases of Shares

The Listing Rules permit companies whose primary listings are on the Stock Exchange to repurchase their shares on the Stock Exchange subject to certain restrictions, the most important of which are summarised below:

(a) Shareholders' approval

The Listing Rules provide that all repurchases of shares on the Stock Exchange by a company with its primary listing on the Stock Exchange must be approved in advance by an ordinary resolution, which may be by way of general mandate, or by specific approval in relation to the repurchase transactions.

(b) Source of funds

Repurchases must be funded out of funds legally available for the purpose in accordance with the memorandum and articles of association of the Company and the laws of the Cayman Islands.

(c) Repurchase by the Company

During each of the six months preceding the date of this circular, no Shares have been repurchased by the Company.

(d) Share prices

RE-ELECTION OF DIRECTORS

At the AGM, each of Mr. Chan Shu Kin and Dr. Tse Kwok Sang will retire in accordance with article 87(1) of the Articles and they, being eligible, have offered themselves for re-election.

Ordinary resolutions will be proposed at the AGM for the re-election of Mr. Chan Shu Kin and Dr. Tse Kwok Sang. Their particulars are as follows:—

Mr. Chan Shu Kin(陳樹堅)("Mr. Chan"), aged 63, was appointed as an independent non-executive Director of the Company on 15th June, 2015. Mr. Chan is a practicing certified public accountant and is a partner of Messrs. Ting Ho Kwan & Chan, Certified Public Accountants. Mr. Chan has over 40 years of experience in the field of auditing, accounting as well as financial management. He is an associate member of the Institute of Chartered Accountants in England and Wales, a fellow member of each of the Association of Chartered Certified Accountants in the United Kingdom and the Hong Kong Institute of Certified Public Accountants. He is also a Certified Tax Advisor of the Taxation Institute of Hong Kong and the past president of the Society of Chinese Accountants and Auditors.

Mr. Chan is currently an independent non-executive director of Tou Rong Chang Fu Group Limited (formerly known as "PetroAsian Energy Holdings Limited", Stock Code: 850) and PYI Corporation Limited (Stock Code: 498).

The Company and Mr. Chan have renewed an appointment letter, pursuant to which the appointment of Mr. Chan is renewed for a term of 2 years commencing from 15 June 2017 and expiring on 14 June 2019, subject to retirement by rotation and re-election under the Articles of Association of the Company. According to the appointment letter, Mr. Chan will receive a fee of HK\$20,000 per month for acting as an independent non-executive Director. The remuneration of Mr. Chan is determined with reference to his relevant duties and responsibilities with the Group and the prevailing market condition.

Dr. TSE Kwok Sang, aged 61, was appointed as an independent non-executive Director of the Company on 9th July, 2015. He holds a bachelor degree in Chemistry from The University of Hong Kong. He also holds a degree of Master of Business Administration, a master degree in Statistics and a Ph.D. degree in Finance from Michigan State University in the United States. Dr. Tse has also obtained the professional designation of Associate of the Society of Actuaries in the United States. Dr. Tse is currently the Undergraduate Programme Director and Associate Professor of the School of Economics and Finance of The University of Hong Kong. Before joining The University of Hong Kong, Dr. Tse was the Assistant Professor of Finance at the Hong Kong University of Science and Technology; prior to that, he was the Assistant Professor of Finance and Insurance at Indiana University in the United States. Dr. Tse is a Co-opted Executive Councilor of the New Territories Heung Yee Kuk. On 1st July, 2010, Dr. Tse was appointed by the Chief Executive of the HKSAR Government as the Justice of the Peace.

Dr. Tse is currently an independent non-executive director of Wing Lee Property Investments Limited (Stock Code: 864) and Sunlight Real Estate Investment Trust (Stock Code: 435) as well as AP Asset Management (HK) Limited.

The Company and Dr. Tse have renewed an appointment letter, pursuant to which the appointment of Dr. Tse is renewed for a term of 2 years commencing from 9 July 2017 and expiring on 8 July 2019, subject to retirement by rotation and re-election under the articles of association of the Company. According to the appointment letter, Dr. Tse will receive a fee of HK\$20,000 per month for acting as an independent non-executive Director. The remuneration of Dr. Tse is determined with reference to his relevant duties and responsibilities with the Group and the prevailing marketing condition.

Save as disclosed above, as at the Latest Practicable Date, each of Mr. Chan and Dr. Tse does not (i) hold any other position with the Company or its subsidiaries; (ii) hold any other directorships in any other public companies, the securities of which are listed on any securities market in Hong Kong or overseas in the last three years; and (iii) have any relationship with any other Directors, senior management or substantial or controlling Shareholders of the Company (as defined in the Listing Rules).

Save as disclosed above, as at the Latest Practicable Date, each of Mr. Chan and Dr. Tse did not have any interest in the shares or underlying shares of the Company within the meaning of Part XV of the SFO.

Save as disclosed above, as at the Latest Practicable Date, there is no other information relating to the appointment of each of Mr. Chan and Dr. Tse which is required to be disclosed pursuant to Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules and there are no other matters that need to be brought to the attention of the Shareholders.

CLOSURE OF REGISTER OF MEMBERS

For the purposes of ascertaining Shareholders' entitlement to attend and vote at the AGM, the register of members of the Company will be closed from 30 May 2018 (Wednesday) to 4 June 2018 (Monday) (both dates inclusive), during which period no transfer of shares will be effected. In order to qualify for the entitlement to attend and vote

at the forthcoming annual general meeting, all transfer documents, accompanied by the relevant share certificates, must be lodged with the Company's branch share registrar and transfer office of the Company in Hong Kong, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not later than 4:30 p.m. on 29 May 2018 (Tuesday).

The Directors do not recommend the payment of a final dividend for the year ended 31 December 2017.

ANNUAL GENERAL MEETING

A notice convening the AGM to be held on 4 June 2018 (Monday) at Garden Room A&B, 2/F., New World Millennium Hong Kong Hotel, 72 Mody Road, Tsim Sha Tsui East, Kowloon, Hong Kong is set out on pages 8 to 10 of this circular to approve, among other things, the granting of the Share Issue Mandate, the Extension Mandate and the Repurchase Mandate; and the re-election of Directors.

A form of proxy for use at the AGM is enclosed with this circular and such form of proxy is also published on the website of the Stock Exchange at www.hkex.com.hk.
