On 2 March 2010, the Company and Get Nice Securities Limited (the “**Underwriter**”) entered into an underwriting agreement in relation to the underwriting arrangement in respect of Rights Issue at a price of HK\$0.15 per Rights Share on the basis of two Rights Shares for every Share held on the Record Date (the “**Underwriting Agreement**”). Pursuant to the Underwriting Agreement, the Underwriter has conditionally agreed to underwrite the Rights Shares not subscribed by the Qualifying Shareholders on a fully underwritten basis to a maximum extent, being 569,279,762 Rights Shares.
