On 2 March 2010, the Company and Get Nice Securities Limited (the “**Underwriter**”) entered into an underwriting agreement in relation to the underwriting arrangement in respect of Rights Issue at a price of HK\$0.15 per Rights Share on the basis of two Rights Shares for every Share held on the Record Date (the “**Underwriting Agreement**”). The Rights Issue became unconditional after 4:00 p.m. on Thursday, 13 May 2010 and 569,279,762 Rights Shares were fully subscribed by the Shareholders, the Underwriter’s obligations under the Underwriting Agreement in respect of the Underwritten Shares have been fully discharged.
