Remarks (if any):

On 27 July 2010, the Company announced that:

- i. the Company proposed to put forward to the shareholders of the Company the capital reorganisation (“**Capital Reorganisation**”) which will comprise: (a) the consolidation of every twenty issued shares of HK\$0.10 each into one consolidated share of HK\$2.00 each (“**Consolidated Share**”); (b) the reduction in paid-up capital of each Consolidated Share from HK\$2.00 each to HK\$0.01 each by cancelling paid-up capital to the extent of HK\$1.99 on each Consolidated Share so as to form an adjusted share of HK\$0.01 each (“**Adjusted Share**”); (c) the application of the credit arising from such capital reduction to cancel the accumulated deficit of the Company (if any) with the balance (if any) to be transferred to the distributable capital reduction reserve account of the Company; and (d) the sub-division of each of the authorised but unissued shares of HK\$0.10 each into ten Adjusted Shares of HK\$0.01 each; and
- ii. the Company and Get Nice Securities Limited (“**Underwriter**”) entered into a fully underwritten agreement on 27 July 2010, subject to the Capital Reorganisation becoming effective, the Underwriter has conditionally agreed to underwrite not less than 341,567,856 new Adjusted Shares and not more than 444,038,208 new Adjusted Shares by way of rights issue at a price of HK\$0.36 per rights share on the basis of eight rights shares for every Adjusted Share held on the record date.
