On 11 October 2011, the Company announced that the Company and Freeman Securities Limited (the “**Underwriter**”) entered into a fully underwritten agreement on 11 October 2011, the Underwriter has conditionally agreed to underwrite not less than 862,378,676 new shares and not more than 1,121,092,276 new shares to the qualifying shareholders by way of rights issue at a price of HK\$0.10 per rights share on the basis of two rights shares for every share held on the record date. The Rights Issue was approved by the Independent Shareholders by way of poll at the EGM held on 20 January 2011.

862,378,676 Rights Shares (on the basis of 431,189,338 Shares in issue as at the Record Date) were allotted and issued under the Rights Issue on 27 February 2012.
