#### Remarks (if any):

On 23 March 2012, the Company announced that the directors of the Company proposed to put forward to the shareholders the proposal for capital reorganisation ("**Capital Reorganisation**") which will comprise: (i) the share consolidation, whereby every eight (8) issued shares of HK\$0.01 each in the existing share capital of the Company will be consolidated into one (1) consolidated share of HK\$0.08 each ("**Consolidated Share**(s)"); (ii) the capital reduction, whereby the total number of Consolidated Shares in the issued share capital of the Company will be rounded down to the nearest whole number and the paid-up capital of each Consolidated Share will be cancelled to the extent of HK\$0.07 per Consolidated Share so as to form a new shares of HK\$0.01 each ("**Capital Reduction**"); and (iii) the transfer, whereby amount (all or part thereof) standing to the credit of the existing distributable capital reduction reserve account of the Company and the credits arising from the Capital Reduction will be applied towards cancelling the accumulated losses of the Company, with the balance (if any) be transferred to the distributable capital reduction reserve account of the Company.

The Capital Reorganisation was duly passed by the shareholders by way of poll at the extraordinary general meeting of the Company held on 17 May 2012.
