Remarks (if any):

The capital reorganisation of the Company (the “**Capital Reorganisation**”) became effective on 20 February 2020 (Hong Kong time) which involves, among others, the following :-

- a) the reduction of the par value of each issued share from HK\$0.10 to HK\$0.0001;
- b) the sub-division of each authorised but unissued share into 1,000 new shares of HK\$0.0001 each (each a “**New Share**”); and
- c) the consolidation of the New Shares on the basis that every 10 issued and unissued New Shares of HK\$0.0001 each consolidated into one share of HK\$0.001 each (each a “**Consolidated Share**”).

As a result of the Capital Reorganisation, the number of Consolidated Shares falling to be issued upon exercise of the outstanding share options was adjusted to 19,180,000 Consolidated Shares.

Details of the Capital Reorganisation are set out in the circular and announcement of the Company dated 21 October 2019 and 20 February 2020, respectively.
