On 19 May 2020 (after trading hours), the Company and Astrum Capital Management Limited (“Astrum”), the placing agent, entered into a placing agreement pursuant to which the Company appointed Astrum to place, on a best efforts basis and subject to the fulfillment of the condition precedent to the placing, a maximum of 37,246,336 placing shares to not less than six independent places at a price of HK\$0.150 per placing share. As at the date of this monthly return, the placing has not been completed.
