On 19 May 2020 (after trading hours), the Company and Astrum Capital Management Limited ("Astrum"), the
placing agent, entered into a placing agreement pursuant to which the Company appointed Astrum to place, on
a best efforts basis and subject to the fulfillment of the condition precedent to the placing, a maximum of
37,246,336 placing shares to not less than six independent placees at a price of HK\$0.150 per placing share.
The Placing was completed on 5 June 2020 and an aggregate of 37,240,000 placing shares have been allotted
and issued to not less than six independent placees at the placing price of HK\$0.150 per placing share, pursuant
to the terms and condition of the placing agreement.
