The Board is pleased to announce that all the proposed resolutions as set out in the Notice were duly passed by the Shareholders by way of poll at the AGM held on 16 September 2015.

None of the Shareholders stated the intention in the Circular to vote against or to abstain from voting on any of the resolutions at the AGM.
