POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 15 SEPTEMBER 2017

The Board is pleased to announce that all the proposed resolutions as set out in the Notice were duly passed by the Shareholders by way of poll at the AGM held on 15 September 2017.

Reference is made to the circular (the “Circular”) incorporating a notice of the annual general meeting (the “Notice”) of Herald Holdings Limited (the “Company”) dated 24 July 2017. Unless otherwise specified, capitalised terms used in this announcement shall have the same meaning as those defined in the Circular.

POLL RESULTS OF THE AGM

The Board is pleased to announce that all the proposed resolutions as set out in the Notice were duly passed by the Shareholders by way of poll at the annual general meeting held on 15 September 2017 (the “AGM”).

Tricor Tengis Limited, the Company’s branch share registrar in Hong Kong, was appointed as the scrutineer for the vote-taking at the AGM. The poll results in respect of the ordinary resolutions proposed at the AGM are as follows:

There were no shares entitling the Shareholders to attend and abstain from voting in favour of any of the resolutions at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") and there were no Shareholders that are required under the Listing Rules to abstain from voting at the AGM. None of the Shareholders stated the intention in the Circular to vote against or to abstain from voting on any of the resolutions at the AGM.
