ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

- The Offer Price has been determined at HK\$1.03 per Offer Share (exclusive of brokerage fee of 1.0%, SFC transaction levy of 0.003% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$1.03 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting fees and estimated expenses in connection with the Share Offer, are estimated to be approximately HK\$99.5 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future plans and use of proceeds – Use of proceeds” in the Prospectus.
- A total of 8,409 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms for a total of 4,129,756,000 Public Offer Shares, representing approximately 413 times of the total number of 10,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to the very significant over-subscription in the Public Offer, the adjustment procedures as described in the section headed “Structure and conditions of the Share Offer – The Public Offer – Allocation” in the Prospectus have been applied and the number of Offer Shares allocated to the Public Offer has been increased to 50,000,000 Offer Shares, representing 43.5% of the total number of Offer Shares available under the Share Offer (after adjustment and the exercise of the Offer Size Adjustment Option).
- The Placing Shares initially offered under the Placing have been significantly over-subscribed.
- The Offer Size Adjustment Option has been fully exercised by the Sole Bookrunner to require our Company to issue and allot additional 15,000,000 Placing Shares.
- The final number of Placing Shares allocated to the places under the Placing is 65,000,000 Placing Shares, representing 56.5% of the total number of the Offer Shares available under the Share Offer after the exercise of the Offer Size Adjustment Option.

OFFER PRICE

The Offer Price has been determined at HK\$1.03 per Offer Share (exclusive of brokerage fee of 1.0%, SFC transaction levy of 0.003% and Stock Exchange trading fee of 0.005%).

NET PROCEEDS FROM THE SHARE OFFER

Based on the Offer Price of HK\$1.03 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting fees and estimated expenses in connection with the Share Offer, are estimated to be approximately HK\$99.5 million. The Company intends to apply such net proceeds as follows:

- approximately HK\$79.5 million, representing approximately 80.0% of the net proceeds, will be used for reinforcing and expanding our market share to increase our customer base by expanding our mortgage loan portfolio by providing more loans to existing customers and extending loans to new customers;
- approximately HK\$10.0 million, representing approximately 10.0% of the net proceeds, will be used for marketing activities to improve public awareness of our Company's brand name and our image in Hong Kong, including the enhancing our website, placing advertisements on televisions, radio, newspapers, magazines, online platforms in various forms and public transport, sponsoring popular programmes and well-known events; and
- approximately HK\$10.0 million, representing approximately 10.0% of the net proceeds, will be used for general working capital and general corporate purposes.

To the extent that the net proceeds from the Share Offer are not immediately required to be applied to the above purposes, and to the extent as permitted by applicable laws and regulations, the Company intends that such net proceeds be placed on short-term interest bearing deposits with licensed banks in Hong Kong, or be used to settle the short-term interest-bearing borrowings.

APPLICATION AND INDICATIONS OF INTEREST RECEIVED

The Public Offer Shares initially available under the Public Offer have been very significantly over-subscribed. At the close of the application lists at 12:00 noon on Tuesday, 24 September 2013, a total of 8,409 valid applications (including applications on **WHITE** and **YELLOW** Application Forms) for a total of 4,129,756,000 Public Offer Shares were received pursuant to the Public Offer, representing approximately 413 times of the total number of 10,000,000 Public Offer Shares initially available for subscription under the Public Offer.

- 7,904 valid applications in respect of a total of 1,604,756,000 Public Offer Shares were for the Public Offer with an aggregate subscription amount based on the maximum Offer Price of HK\$1.03 per Offer Share (exclusive of brokerage fee of 1.0%, SFC transaction levy of 0.003% and Stock Exchange trading fee of 0.005%) of HK\$5 million or less, representing approximately 321 times of the 5,000,000 Public Offer Shares initially comprised in Pool A; and
- 505 valid applications in respect of a total of 2,525,000,000 Public Offer Shares were for the Public Offer with an aggregate subscription amount based on the maximum Offer Price of HK\$1.03 per Offer Share (exclusive of brokerage fee of 1.0%, SFC transaction levy of 0.003% and Stock Exchange trading fee of 0.005%) of more than HK\$5 million, representing approximately 505 times of the 5,000,000 Public Offer Shares initially comprised in Pool B.

A total of 14 applications have not been completed in accordance with the instructions set out in the Application Forms and have been rejected. A total of 10 applications have been rejected due to dishonoured cheques. A total of 2 multiple applications or suspected multiple applications have been identified and rejected. No application for more than 5,000,000 Public Offer Shares has been identified.

Due to the very significant over-subscription in the Public Offer, the adjustment procedures as described in the section headed “Structure and conditions of the Share Offer – The Public Offer – Allocation” in the Prospectus have been applied and the number of Offer Shares allocated to the Public Offer has been increased to 50,000,000 Offer Shares, representing 43.5% of the total number of Offer Shares available under the Share Offer (after adjustment and the exercise of the Offer Size Adjustment Option).

The Offer Shares offered in the Public Offer were conditionally allocated on the basis set out in the paragraph headed “Basis of allocation under the Public Offer” below.

PLACING AND OFFER SIZE ADJUSTMENT OPTION

The Placing Shares initially offered under the Placing have been significantly over-subscribed. Following the adjustment of Public Offer above and to cover the excess demand in the Placing, the Offer Size Adjustment Option has been fully exercised by the Sole Bookrunner to require our Company to issue and allot additional 15,000,000 Placing Shares.

The final number of Placing Shares allocated to the places under the Placing is 65,000,000 Placing Shares, representing 56.5% of the total number of Offer Shares available under the Share Offer (after adjustment and the exercise of the Offer Size Adjustment Option).

For avoidance of doubt, the Offer Size Adjustment Option is not associated with any price stabilisation activities of the Shares in the secondary market after the Listing, and is not subject to the Securities and Futures (Price Stabilising) Rules of the SFO and cannot be exercised at any future date.

The Directors confirm that no Offer Shares have been allocated to applicants who are existing Shareholders or connected persons of the Company or their respective associates (both within the meaning of the Listing Rules), whether in their own names or through nominees. None of the Sole Sponsor, the Underwriters or their affiliated companies and connected clients (as set out in Appendix 6 to the Listing Rules) has taken up any Offer Shares for its own benefit under the Share Offer. The Directors confirm that the Placing has been conducted in compliance with the placing guidelines for equity securities as set out in Appendix 6 to the Listing Rules. None of the places under the Placing will become a Substantial Shareholder (within the meaning of the Listing Rules) of the Company after the Placing and the Company’s public float percentage will be 25% which meets the minimum percentage prescribed by Rule 8.08(1)(a) of the Listing Rules.
