If the Company does not receive the duly completed Reply Form from you (or another response from you indicating that you object to the Email Option) by 15 March 2024, you will be implied to consent, until you inform the Company otherwise by reasonable notice in writing to the Hong Kong Branch Share Registrar at the above address or by email to 1273-corpcomm@unionregistrars.com.hk, to have elected to receive printed notification letter of the publication of the Corporate Communications on the Websites. In future, when the Company publishes any Corporate Communications on the Websites, it will only send to you a notification letter that the Corporate Communications have been made available on the Websites. The notification will be sent to you by email (if you have provided a valid email address) or by post (if you have not provided an email address or the email address is invalid) at your address as it appears in the Company's register of members maintained by the Hong Kong Branch Share Registrar.

You may at any time send your request in writing to the Company (c/o its Hong Kong Branch Share Registrar by post at the above address or by email to 1273-corpcomm@unionregistrars.com.hk) to request for printed copies of the Corporate Communications.
