### CHAIRMAN'S STATEMENT

## 主席報告

On behalf of the Board of Directors, I am delighted to present to the shareholders of Hop Fung Group Holdings Limited (hereafter "the Group", "us" or "we") the 2014 annual report of the Group.

本人謹代表董事會欣然向各位股東提呈合豐集團控股有限公司(「本公司」,連同其附屬公司,統稱「本集團」、「集團」或「我們」)的二零一四年度全年業績報告。

Facing a slow economic recovery around the world, a moderating Chinese economy and the depreciation of the Renminbi, we saw no impetus in demand growth. Despite loose monetary policies in Europe and the United States, economic reforms in emerging markets and lower interest rates in China, the economic environment remains unstable as a whole and uncertainty persists.

面對環球經濟復甦緩慢、中國經濟增長放緩及人民幣 貶值,需求難有增長動力。縱使歐美繼續實施寬鬆貨 幣政策,新興市場國家推行經濟改革,中國政府將利 率下調,但經濟環境仍未見穩定,不明朗因素依然存 在。

Most industries in China were affected by moderating growth and the corrugated packaging industry was no exception. In addition to a lack of growth in demand, selling prices have also been capped by the oversupply situation and ferocious competition in recent years. Earnings for manufacturers depressed and some of our competitors closed as a result.

國內大部分行業因經濟增長乏力而大受影響, 瓦楞紙品包裝業也不能幸免。除市場需求未有大增幅外,銷售價格也因近年產能過剩及競爭激烈而難以上調,企業盈利受壓,部分更因此而倒閉。

2014 was a year of challenges and opportunities for the Group. With more than 80% of revenue from the domestic market in the mainland of China, the performance of the local economy directly impacted on our operations. In addition to adjusting our marketing strategy on the back of changes in market conditions, we also secured our sales position through developing new customers. As a result, despite a fall in selling prices in 2014, our sales volume rose, resulting in nearly 7% year on year growth in revenue for the year.

二零一四年對本集團而言是充滿挑戰與機遇的一年。由於集團超過八成的收益來自中國內銷市場,國內之經濟情況直接影響集團之表現。為鞏固收益,集團除因應市場需求變化而改變營銷策略外,也積極努力開拓新客源,縱使二零一四年之銷售價下跌,銷量卻上升,收益最終錄得近7%的增長。

In order to maintain a prudent financial situation, we strive to continuously improve our production processes to reduce costs and wastage, and to concentrate on selling products with shorter turnaround time to reduce working capital needs. We also endeavor to reduce our debt in order to bring down our finance costs. In 2014, not only did we achieve improvements in operating profit, we also maintained low inventory levels, low gearing levels and almost no bad debts.

集團為保持穩健的財務狀況,持續改進生產流程以減低成本和損耗,專注營銷週期較短的產品以減少存貨及資金被積壓的情況,並竭力將債務減低使財務成本下降。集團在二零一四年不單只營運利潤錄得上升,更可保持低存貨量、低負債及接近零壞賬的記錄。

The Group sold a subsidiary in December 2014 for a net profit of HK\$378.8 million. 49% of the consideration has already been collected, with the remaining 51% due to be paid to us in December 2016. As the Group currently has no acquisition targets, the funds will be used for our working capital. As a result, the Group's net gearing has declined to around 8%, building up a more solid financial position.

集團於二零一四年十二月出售一間附屬公司,錄得利潤約港幣378,800,000元,此交易之49%代價已收取,餘下51%代價將於二零一六年十二月收取。由於集團未有任何待收購目標,故資金用作一般營運用途。集團之淨負債比率下降至約8%,財務狀況更為穩健。

## **CHAIRMAN'S STATEMENT**

主席報告

Going forward, we are optimistic towards 2015. The global economy is expected to steadily recover and the Chinese economy should continue with its stable growth trajectory, with increasing domestic demand reducing the reliance on exports. In addition, environmental protection issues have prompted the Chinese government to push forward with policies to reduce outdated capacity in the corrugated packaging industry. This should provide relief to the excess capacity plaguing the industry and we believe selling prices can be raised to more reasonable levels.

展望未來,我們對二零一五年抱著樂觀的態度,預期全球經濟復甦步伐平穩,中國將穩中求進,繼續推動內銷以減低對出口的依賴,使國內市場需求上升。此外,基於環保問題,中國政府已落實推行政策,於瓦楞紙品包裝業淘汰落後產能,產能過剩的情況將得到改善,我們相信銷售價能向上調整至合理水平。

The Group will maintain its roots in China, take advantage of the opportunities afforded by China's development and expand our market share. We will also grasp the competitive advantages of our vertically integrated business model in order to maintain steady long term growth and a stable financial situation, in order to achieve optimal levels of profitability.

集團將會繼續札根中國,把握國內的巨大發展機遇, 擴大市場份額,並抓緊由縱向整合的營運模式所帶來 的競爭優勢,使集團維持長遠穩定的增長和穩健的財 務狀況,務求達致可觀的利潤。

管理層討論及分析

#### **BUSINESS REVIEW**

The corrugated packaging industry was still in over supply in 2014. Selling prices were under pressure, falling by around 3% to 7%, and market demand growth was limited due to a slowing economy. Thankfully, improvements to the Group's marketing strategy resulted in higher sales volume and revenue rose 6.9% for the year. For the first half of 2014, revenue rose 8.4% against the first half of 2013. Revenue for the second half of 2014 rose 21.0% compared to the first half of 2014, and 5.7% compared to the second half of 2013. Export and domestic revenue rose 10.8% and 6.1%, respectively, in 2014.

The Group's upstream operation, producing linerboard and corrugating medium, mainly supplies to the Group's downstream business, making corrugated paperboards and carton boxes. In addition, depending on market conditions, our upstream products can also be sold directly to customers, and in 2014 around 32% of upstream products were directly sold to customers. The upstream and downstream businesses accounted for around 27% and 73% of revenue in 2014, respectively. Upstream revenue rose around 56%, with lower selling prices but higher volumes, and capacity utilization came to more than 80%. Downstream revenue fell around 4%, with lower selling prices and flat volumes, and capacity utilization came to more than 60%.

Prices for waste paper, our main raw materials, fell slightly year on year, but we saw pressure from higher wages and shipping costs. Continuous improvements in production methods to improve efficiency and reduce wastage have resulted in cost increases that were aligned to revenue gains.

The Group sold a subsidiary in December 2014, which had minimal impact on our core operations. We expect to move two downstream production lines in two years' time, and during removal the short fall in capacity can be taken up by other production lines. The subsidiary was sold for RMB380.0 million, of which 49% had already been received with the remaining 51% due in December 2016. This disposal results in a net gain of HK\$378.8 million which substantially builds up our cash position and enhances our financial position.

#### 業務回顧

於二零一四年瓦楞紙品包裝業仍處於供過於求的情況, 集團銷售價格受壓,下跌約3%至7%,市場需求因經 濟放緩而未有大幅上升。幸而集團改變營銷策略使銷 量上升,故收益上升6.9%。上半年之收益比二零一三 年同期上升8.4%。下半年收益較上半年高出21.0%, 對比二零一三年同期則上升5.7%。集團二零一四年出 口收益及內銷收益分別增加10.8%及6.1%。

集團上游箱板紙業務生產之瓦楞芯紙及牛咭,主要提供予集團下游的瓦楞包裝業務製造瓦楞紙板及紙箱,另因應市場變化而售予客戶,於二零一四年約32%上游產品售予客戶。上下游業務分別佔收益約27%及73%,上游之收益上升約56%,銷售價下跌但銷量增加,設備使用率超過八成;而下游之收益減少約4%,銷售價下跌而銷量平穩,設備使用率超過六成。

集團主要原材料廢紙的價格與去年相比也略為下跌, 但工資及運輸費用均有上漲壓力。然而,集團持續優 化生產流程以提高效益及減少損耗,使成本增幅與收 益增幅相符。

集團於二零一四年十二月出售一間附屬公司,此舉對集團業務運作影響極小,預計有兩條下游生產線需於兩年後遷移,遷移期間,其生產可由其他生產線承擔。出售代價為人民幣380,000,000元正,49%代價已收取,餘下51%代價將於二零一六年十二月收取,此項交易使集團錄得約378,800,000港元的盈利,使集團資金非常充裕,財務更加穩健。

#### **FINANCIAL REVIEW**

#### **Operating results**

The Group recorded a rise in revenue by 6.9%, from HK\$1,026.6 million in 2013 to HK\$1,097.1 million in 2014. The effect of the drop in average selling price was offset by the growth in sales volume, leading to such increase.

The rise in cost of sales by 7.1% was in line with the rise in revenue. Gross profit increased 5.8%, from HK\$173.6 million to HK\$183.6 million. Gross profit margin was 16.7% (2013: 16.9%).

The increase in other income from HK\$12.7 million to HK\$15.9 million was mainly attributable to the interest income earned from receivable.

Selling and distribution costs increased in line with the rise in revenue by 5.1% from HK\$60.4 million to HK\$63.5 million.

There was an increase of 5.0% in administrative expenses from HK\$71.6 million to HK\$75.2 million. Such increment was caused by increasing staff cost and the share based payment arising from the grant of share options in October 2013.

Other expenses increased 4.2%, from HK\$23.7 million to HK\$24.7 million. The rise was predominantly due to exchange loss arising from the depreciation of Renminbi. Provision for doubtful debts of HK\$0.4 million was made for the year.

EBITDA from operation (earnings before interest, tax, depreciation and amortization and unrealized changes in fair value of derivative financial instruments) rose 2.5%, from HK\$114.0 million to HK\$116.9 million.

A decline in finance costs of 13.0%, from HK\$24.7 million to HK\$21.5 million, was owing to lower average borrowing level maintained throughout the year.

Unrealized changes in fair value of derivative financial instruments of HK\$0.9 million was only recognized for accounting purpose. It was non-cash in nature and would be reversed to zero at maturity date.

Profit from operation (excluding unrealized changes in fair value of derivative financial instruments) rose HK\$6.0 million from HK\$5.3 million to HK\$11.3 million. The profit margin from operation improved from 0.5% to 1.0%. The rise was mainly resulted from growth in sales volume and fall in finance cost.

#### 財務回顧

#### 經營業績

本集團錄得之收益由二零一三年之1,026,600,000港元增加6.9%至二零一四年之1,097,100,000港元,有關增長乃由於平均售價下跌之影響被銷量增加抵銷所致。

銷售成本上升7.1%,與收益同步增加。毛利由 173,600,000港元增加5.8%至183,600,000港元。毛利 率為16.7%(二零一三年:16.9%)。

其他收入由12,700,000港元增加至15,900,000港元· 主要由於應收款項賺取利息收入所致。

銷售及分銷成本與收益同步增長,由60,400,000港元增加5.1%至63,500,000港元。

行政開支由71,600,000港元增加5.0%至75,200,000港元,有關增加乃由於員工成本增加及於二零一三年十月授出購股權產生的以股份支付之支出所致。

其他開支由23,700,000港元增加4.2%至24,700,000港元,有關增加主要由於人民幣貶值產生匯兑虧損所致。 本年度就呆賬撥備400,000港元。

息税折舊攤銷前之營運利潤(未計利息、税項、折舊及攤銷以及衍生金融工具公平值之未變現變動之利潤)由114,000,000港元增加2.5%至116,900,000港元。

財務成本由24,700,000港元減少13.0%至21,500,000港元,乃由於整個年度之平均借貸水平減少所致。

衍生金融工具公平值之未變現變動900,000港元僅就 會計處理目的而確認。其屬非現金性質,將於到期日 回撥為零。

營運利潤(衍生金融工具公平值之未變現變動除外)由5,300,000港元增加6,000,000港元至11,300,000港元。 營運利潤率由0.5%增加至1.0%。有關增加主要由於銷量增加及財務成本減少所致。

## 管理層討論及分析

Gain on disposal of a subsidiary of HK\$378.8 million arose from the disposal of Fung Kong Hop Fung Paper Ware Factory Limited ("FKHF"), a subsidiary of Hop Fung Group Company Limited. It represents the net gain from the disposal, being the cash consideration received and the present value of the cash consideration receivables less transaction costs and the carrying amount of assets and liabilities of FKHF before disposal. The details of the disposal were stated in the circular issued by the Group on 27th November, 2014.

出售附屬公司之收益378,800,000港元乃由出售Hop Fung Group Company Limited之附屬公司-鳳崗合豐紙品廠有限公司(「鳳崗合豐」)所產生,這代表出售所產生之收益淨額,即已收現金代價與應收現金代價之現值減交易成本及鳳崗合豐於出售前之資產及負債賬面值。有關出售詳情載於本集團於二零一四年十一月二十七日刊發之通函內。

Both basic and diluted earnings per share increased from 0.81 HK cents to 53.70 HK cents and 52.90 HK cents respectively.

每股基本及攤薄盈利由0.81港仙分別增加至53.70港仙及52.90港仙。

#### Liquidity, financial and capital resources

# At 31st December, 2014, the Group's total cash and cash equivalents were HK\$394.0 million (31st December, 2013: HK\$239.8 million), mostly denominated in Renminbi. The surge primarily came from the cash inflow from disposal of a subsidiary near year end.

Net current assets and current ratio of the Group were HK\$177.6 million (31st December, 2013: HK\$31.1 million) and 1.33 (31st December, 2013: 1.06) respectively.

The Group spent HK\$37.5 million on capital expenditures for maintenance and technical upgrade to the production lines and the ancillary facilities.

Stock turnover days decreased from 53 days to 43 days. Debtors turnover days increased from 64 days to 67 days. Creditors turnover days decreased from 61 days to 39 days.

Total bank borrowings fell HK\$127.3 million, from HK\$645.6 million to HK\$518.3 million. Gearing ratio was greatly improved, declining from 56.2% to 33.8%. The current bank borrowings were down HK\$51.0 million and the non-current bank borrowings were down HK\$76.3 million. The balance for total bank borrowings net of bank balances and cash dropped HK\$281.5 million, from HK\$405.8 million to HK\$124.3 million. Net gearing ratio was enormously improved, falling from 35.3% to 8.1%.

Receivable from disposal of a subsidiary of HK\$229.1 million represents the present value of the remaining 51% of the cash consideration receivable from the completion of the disposal in December 2016.

#### 流動資金、財務及資本資源

於二零一四年十二月三十一日,本集團大部分以人民幣列值之現金及現金等值總額約達394,000,000港元(二零一三年十二月三十一日:239,800,000港元)。有關增加主要由於接近年結時出售附屬公司所產生之現金流入。

本集團之流動資產淨值及流動比率分別為177,600,000港元(二零一三年十二月三十一日:31,100,000港元)及1.33(二零一三年十二月三十一日:1.06)。

本集團之資本開支為37,500,000港元,用於為生產線及配套設施進行維修及技術升級。

存貨流轉率由53日減少至43日。應收賬款之流轉率由64日增加至67日。應付賬款之流轉率由61日減少至39日。

銀行借貸總額減少127,300,000港元,由645,600,000港元減至518,300,000港元。負債比率大幅改善,由56.2%下降至33.8%。即期銀行借貸及非即期銀行借貸分別減少51,000,000港元及76,300,000港元。銀行借貸總額減銀行結餘及現金之淨額由405,800,000港元減少281,500,000港元至124,300,000港元。淨負債比率顯著改善,由35.3%下降至8.1%。

出售附屬公司之應收款項為229,100,000港元,為於二零一六年十二月完成出售之應收餘下51%現金代價之現值。

管理層討論及分析

#### **Contingent liabilities**

The tax audits conducted by the Inland Revenue Department ("IRD") on the Company and its subsidiaries for the years of assessment 2004/2005 to 2010/2011 are still on-going. The IRD had issued protective assessments for the years of assessment 2004/2005 to 2010/2011 to certain subsidiaries of the Group. Objections were lodged against all these assessments. The Directors believe that no additional provision for Hong Kong profits tax is necessary at the present stage. The outcome and impact of this matter cannot be determined with reasonable certainty.

#### OUTLOOK

We expect gradual improvements to the global economy. Both exports and domestic sales should see growth. The Renminbi exchange rate is fluctuating but is less volatile compared to other global currencies. Tightening environmental protection regulations in China are prompting capacity closures in the corrugated packaging industry. We expect relief on the oversupply situation in the industry to prompt a recovery in pricing to more reasonable levels. Our strategy is to improve our production efficiency, increase our sales volume and reduce our raw materials wastage and energy usage to offset the impact of rising costs, in order to improve profitability for the Group.

#### **HUMAN RESOURCES**

As at 31st December, 2014, the Group and the processing factory employed a total workforce of around 1,100 full time staff (2013: 1,150). Competitive remuneration packages were offered to employees. The Group may also grant share options and discretionary bonuses to eligible employees based on the performance of the Group and individuals.

#### 或然負債

香港税務局(「税務局」)仍在就本公司及其附屬公司之二零零四年/二零零五年至二零一零年/二零一一年課税年度進行税務稽查。税務局曾就二零零四年/二零零五年至二零一零年/二零一一年之課税年度向本集團若干附屬公司發出保障性評税。本集團已就所有該等評税提出反對。董事認為現階段無需就香港利得税作出額外撥備,亦未能合理確定此事宜之結果及影響。

#### 展望

我們預期環球經濟將會逐漸改善,出口及內銷市場需求必有所增長,人民幣匯率雖有波動,但波幅較其他環球貨幣小,相對穩定。中國收緊了環保條例,淘汰瓦楞紙品包裝業的落後產能,我們相信行業的產能過剩問題將獲得改善,銷售價格將可回升至合理水平。我們承諾繼續以提升生產效率、增加銷量、降低原料損耗及能源消耗以抗衡成本上漲為重點策略,竭力提高集團的利潤。

#### 人力資源

於二零一四年十二月三十一日,本集團及加工廠房僱用總共約1,100名全職員工(二零一三年:1,150名)。本集團向僱員提供具競爭力之薪酬福利。本集團可能亦會授出購股權及酌情花紅予合資格僱員,授出之基準按本集團及個人之表現而釐定。

#### **Executive Directors**

Mr. Hui Sum Kwok, aged 55, is the chairman of the Board, the executive Director of the Company and a co-founder of the Group. Mr. Hui is responsible for the overall corporate planning, business development and management of the Group. Mr. Hui has over 30 years of experience in the corrugated packaging industry in Hong Kong and the PRC.

Mr. Hui Sum Kwok is a brother of Mr. Hui Sum Ping (vice chairman of the Board, executive Director, and substantial shareholder of the Company) and Mr. Hui Sum Tai (executive Director and chief executive officer of the Company), and the spouse of Ms. Wong Mui (deputy general manager of the Company). Mr. Hui did not hold any other directorship in companies listed in Hong Kong or overseas in the last 3 years.

**Mr. Hui Sum Ping**, aged 53, is the vice chairman of the Board, the executive Director of the Company and a co-founder of the Group. Mr. Chee Man Sang. Eric has been serving as Independent Non-executive Director for more than 9 years. Pursuant to code provision A.4.3 of the CG Code, his further appointment should be subject to the passing of a separate resolution by the shareholders at the forthcoming annual general meeting of the Company.

#### Non-executive Directors and Directors' Re-election

Code provision A.4.1 of the CG Code stipulates that Nonexecutive Directors shall be appointed for a specific term, subject to re-election, whereas code provision A.4.2 states that all directors appointed to fill a casual vacancy should be subject to election by shareholders at the first general meeting after appointment and that every director, including those appointed for a specific term, should be subject to retirement by rotation at least once every three years.

Each of the Independent Non-executive Directors of the Company is appointed for a specific term of two years and is subject to retirement by rotation at least once every three years.

#### Responsibilities, Accountabilities and Contributions of the Board and Management

The Board is responsible for leadership and control of the Company and oversees the Group's businesses, strategic decisions and performance and is collectively responsible for promoting the success of the Company by directing and supervising its affairs. The Directors take decisions objectively in the interests of the Company.

#### 1. GENERAL

The Company is an exempted company with limited liability incorporated in the Cayman Islands under the Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands and its shares are listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). Its parent is Hop Fung Industries Limited, a company incorporated in the British Virgin Islands and its ultimate parent is Hop Fung Industries (Holdings) Limited, a company also incorporated in the British Virgin Islands. The address of the registered office of the Company is disclosed under Corporate Information section of the annual report.

The consolidated financial statements are presented in Hong Kong dollars ("HKD"), which is also the functional currency of the Company.

The Company acts as an investment holding company. The principal activities of its principal subsidiaries are set out in note 34.

#### **HKFRS 9 Financial Instruments**

HKFRS 9 issued in 2009 introduced new requirements for the classification and measurement of financial assets. HKFRS 9 was subsequently amended in 2010 to include requirements for the classification and measurement of financial liabilities and for derecognition, and further amended in 2013 to include the new requirements for general hedge accounting. Another revised version of HKFRS 9 was issued in 2014 mainly to include a) impairment requirements for financial assets and b) limited amendments to the classification and measurement requirements by introducing a 'fair value through other comprehensive income' (FVTOCI) measurement category for certain simple debt instruments.

Key requirements of HKFRS 9 are described below:

All recognised financial assets that are within the scope of HKAS 39 Financial Instruments: Recognition and Measurement are subsequently measured at amortised cost or fair value. Specifically, debt investments that are held within a business model whose objective is to collect the contractual cash flows, and that have contractual cash flows that are solely payments of principal and interest on the principal outstanding are generally measured at amortised cost at the end of subsequent accounting periods. Debt instruments that are held within a business model whose objective is achieved both by collecting contractual cash flows and selling financial assets, and that have contractual terms of the financial asset giving rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding, are measured at FVTOCI. All other debt investments and equity investments are measured at their fair value at the end of subsequent accounting periods. In addition, under HKFRS 9, entities may make an irrevocable election to present subsequent changes in the fair value of an equity investment (that is not held for trading) in other comprehensive income, with only dividend income generally recognised in profit or loss.

- With regard to the measurement of financial liabilities designated as at fair value through profit or loss. HKFRS 9 requires that the amount of change in the fair value of the financial liability that is attributable to changes in the credit risk of that liability is presented in other comprehensive income, unless the recognition of the effects of changes in the liability's credit risk in other comprehensive income would create or enlarge an accounting mismatch in profit or loss. Changes in fair value of financial liabilities attributable to changes in the financial liabilities' credit risk are not subsequently reclassified to profit or loss. Under HKAS 39, the entire amount of the change in the fair value of the financial liability designated as fair value through profit or loss was presented in profit or loss.
- In relation to the impairment of financial assets, HKFRS 9 requires an expected credit loss model, as opposed to an incurred credit loss model under HKAS 39. The expected credit loss model requires an entity to account for expected credit losses and changes in those expected credit losses at each reporting date to reflect changes in credit risk since initial recognition. In other words, it is no longer necessary for a credit event to have occurred before credit losses are recognised.
- The new general hedge accounting requirements retain the three types of hedge accounting. However, greater flexibility has been introduced to the types of transactions eligible for hedge accounting, specifically broadening the types of instruments that qualify for hedging instruments and the types of risk components of non-financial items that are eligible for hedge accounting. In addition, the effectiveness test has been overhauled and replaced with the principle of an 'economic relationship'. Retrospective assessment of hedge effectiveness is also no longer required. Enhanced disclosure requirements about an entity's risk management activities have also been introduced.

The directors of the Company will assess the impact of the application of HKFRS 9. However, it is not practicable to provide a reasonable estimate of that effect until a detailed review has been completed. 2. 新訂及經修訂之香港財務報告準則(「香港財務報告準則」) 之應用(續)

#### **HKFRS 15 Revenue from Contracts with Customers**

In July 2014, HKFRS 15 was issued which establishes a single comprehensive model for entities to use in accounting for revenue arising from contracts with customers. HKFRS 15 will supersede the current revenue recognition guidance including HKAS 18 Revenue, HKAS 11 Construction Contracts and the related Interpretations when it becomes effective.

The core principle of HKFRS 15 is that an entity should recognise revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods or services. Specifically, the Standard introduces a 5-step approach to revenue recognition:

- Step 1: Identify the contract(s) with a customer
- Identify the performance obligations in the Step 2: contract
- Step 3: Determine the transaction price
- Step 4: Allocate the transaction price to the performance obligations in the contract
- Step 5: Recognise revenue when (or as) the entity satisfies a performance obligation

Under HKFRS 15, an entity recognises revenue when (or as) a performance obligation is satisfied, i.e. when 'control' of the goods or services underlying the particular performance obligation is transferred to the customer. Far more prescriptive guidance has been added in HKFRS 15 to deal with specific scenarios. Furthermore, extensive disclosures are required by HKFRS 15.

The directors of the Company will assess the impact of the application of HKFRS 15. However, it is not practicable to provide a reasonable estimate of the effect of HKFRS 15 until the Group performs a detailed review.

Other than as described above, the directors of the Company anticipate that the application of the other new and revised HKFRSs will have no material impact on the results and the financial position of the Group.

於二零一四年七月,香港財務報告準則第15號已 頒佈,其制定一項單一全面模式供實體用於將來 自客戶合約所產生之收入入賬。香港財務報告準 則第15號生效時,將取代現時之收入確認指引, 包括香港會計準則第18號「收入」、香港會計準則 第11號「建築合約」及相關詮釋。

香港財務報告準則第15號之核心原則為實體應確 認收入以描述向客戶轉讓承諾之貨物或服務,金 額應為能反映該實體預期就交換該等貨物或服務 有權獲得之代價。具體而言,該準則引入了一個 包含五個確認收入步驟之方法:

- 第一步: 識別與客戶之合約
- 第二步:識別合約中之履約責任
- 第三步: 釐定交易價格
- 第四步:將交易價格分配至合約中之履約責 任
- 第五步:當(或隨著)實體履行履約責任時 確認收入

根據香港財務報告準則第15號,當(或隨著)實體 履行履約責任時確認收入,即於特定履約責任相 關之貨物或服務之「控制權」轉讓予客戶時。香港 財務報告準則第15號已加入更多規定性指引以處 理特定情況。此外,香港財務報告準則第15號要 求作出廣泛之披露。

本集團董事將評估應用香港財務報告準則第15號 之影響。然而,於本集團完成詳細審閱前,就有 關香港財務報告準則第15號之影響作合理估算並 不可行。

除上文所述外,本公司董事預期應用其他新訂及 經修訂香港財務報告準則將不會對本集團之業績 及財務狀況構成重大影響。

#### Statement of compliance

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and by Hong Kong Companies Ordinance (Cap. 32).

#### **Basis of preparation**

The consolidated financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/ or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2, leasing transactions that are within the scope of HKAS 17, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 or value in use in HKAS 36.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The principal accounting policies are set out below.

#### Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of subsidiaries acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

# Changes in the Group's ownership interests in existing subsidiaries

When the Group loses control of a subsidiary, a gain or loss is recognised in profit or loss and is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the previous carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interests. All amounts previously recognised in other comprehensive income in relation to that subsidiary are accounted for as if the Group had directly disposed of the related assets or liabilities of the subsidiary (i.e. reclassified to profit or loss or transferred to another category of equity as specified/permitted by applicable HKFRSs).

#### **Revenue recognition**

Revenue is measured at the fair value of the consideration received or receivable and represents amounts receivable for goods sold and services provided in the normal course of business, net of discounts and sales related taxes.

Revenue from the sale of goods is recognised when the goods are delivered and titles have passed, at which time all the following conditions are satisfied:

- the Group has transferred to the buyer the significant risks and rewards of ownership of the goods;
- the Group retains neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the goods sold;
- the amount of revenue can be measured reliably;
- it is probable that the economic benefits associated with the transaction will flow to the Group; and
- the costs incurred or to be incurred in respect of the transaction can be measured reliably.

Service income is recognised when services are provided.

Interest income from a financial asset is recognised when it is probable that the economic benefits will flow to the Group and the amount of income can be measured reliably. Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts the estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

#### Property, plant and equipment

Property, plant and equipment including leasehold land and buildings held for use in the production or for administrative purposes, other than construction in progress as described below, are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Depreciation is recognised so as to write off the cost of items of property, plant and equipment, other than construction in progress, over their estimated useful lives and after taking into account of their estimated residual value, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

Construction in progress includes property, plant and equipment in the course of construction for production or for its own use purposes. Construction in progress is carried at cost less any recognised impairment loss. Construction in progress is classified to the appropriate category of property, plant and equipment when completed and ready for intended use. Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use.

Assets held under finance leases are depreciated over their expected useful lives on the same basis as owned assets. However, when there is no reasonable certainty that ownership will be obtained by the end of the lease term, assets are depreciated over the shorter of the lease term and their useful lives.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

#### **Inventories**

Inventories are stated at the lower of cost and net realisable value. Cost of inventories are determined on a first-in, first-out method. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

#### Impairment losses on tangible assets

At the end of the reporting period, the Group reviews the carrying amounts of its tangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss, if any. When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cash-generating units, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.

Recoverable amount is the higher of fair value less costs to sell and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a cashgenerating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or a cashgenerating unit) is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss.

Where an impairment loss subsequently reverses, the carrying amount of the asset (or cash-generating unit) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or a cash-generating unit) in prior years. A reversal of an impairment loss is recognised immediately in profit or loss.

#### **Provisions**

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, it is probable that the Group will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation.

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (when the effect of the time value of money is material).

When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.

#### **Financial instruments**

Financial assets and financial liabilities are recognised in the consolidated statement of financial position when a group entity becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets or financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in profit or loss.

#### Financial assets

The Group's financial assets comprise financial assets at fair value through profit or loss ("FVTPL") and loans and receivables. The classification depends on the nature and purpose of the financial assets and is determined at the time of initial recognition. All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace.

#### Effective interest method

The effective interest method is a method of calculating the amortised cost of a debt instrument and of allocating interest income over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the debt instrument, or, where appropriate, a shorter period to the net carrying amount on initial recognition.

Interest income is recognised on an effective interest basis for debt instruments other than those financial assets classified as at FVTPL, of which interest income is included in changes in fair value of derivative financial instruments.

Financial assets at FVTPL comprise financial assets held for trading.

A financial asset is classified as held for trading if:

- it has been acquired principally for the purpose of selling it in the near term; or
- it is part of a portfolio of identified financial instruments that the Group manages together and has a recent actual pattern of short-term profit-taking; or
- it is a derivative that is not designated and effective as a hedging instrument.

Financial assets at FVTPL are measured at fair value, with changes in fair value arising from remeasurement recognised directly in profit or loss in the period in which they arise. The changes in fair value of derivative financial instruments recognised in profit or loss include any dividend or interest earned on the financial assets.

#### Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. Subsequent to initial recognition, loans and receivables (including receivables from disposal of a subsidiary, trade and other receivables, and bank balances and cash) are measured at amortised cost using the effective interest method, less any identified impairment losses (see accounting policy on impairment loss on financial assets below).

Financial assets, other than those at FVTPL, are assessed for indicators of impairment at the end of each reporting period. Financial assets are considered to be impaired when there is objective evidence that, as a result of one or more events that occurred after the initial recognition of the financial asset, the estimated future cash flows of the financial assets have been affected.

Objective evidence of impairment could include:

- significant financial difficulty of the issuer or counterparty; or
- breach of contract, such as a default or delinquency in interest or principal payments; or
- it becoming probable that the borrower will enter bankruptcy or financial re-organisation; or
- the disappearance of an active market for that financial asset because of financial difficulties.

For certain categories of financial assets, such as trade receivables, assets that are assessed not to be impaired individually are, in addition, assessed for impairment on a collective basis. Objective evidence of impairment for a portfolio of receivables could include the Group's past experience of collecting payments, an increase in the number of delayed payments in the portfolio past the average credit period ranged from 5 to 150 days, as well as observable changes in national or local economic conditions that correlate with default on receivables.

For financial assets carried at amortised cost, the amount of the impairment loss recognised is the difference between the asset's carrying amount and the present value of estimated future cash flows discounted at the financial asset's original effective interest rate.

Changes in the carrying amount of the allowance account are recognised in profit or loss. When a trade receivable is considered uncollectible, it is written off against the allowance account. Subsequent recoveries of amounts previously written off are credited to profit or loss.

For financial assets measured at amortised cost, if, in a subsequent period, the amount of the impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment was recognised, the previously recognised impairment loss is reversed through profit or loss to the extent that the carrying amount of the asset at the date the impairment is reversed does not exceed what the amortised cost would have been had the impairment not been recognised.

The effective interest method is a method of calculating the amortised cost of a financial liability and of allocating interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

Interest expense is recognised on an effective interest basis other than those financial liability classified as at FVTPL, of which the interest expense is included in changes in fair value of derivative financial instruments.

Financial liabilities at fair value through profit or loss

Financial liabilities at FVTPL comprise financial liabilities held for trading.

#### Derecognition

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group continues to recognise the asset to the extent of its continuing involvement and recognises an associated liability. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

The fair value of services received determined by reference to the fair value of share options granted at the grant date is expensed on a straight-line basis over the vesting period, with a corresponding increase in equity (share options reserve).

At the end of the reporting period, the Group revises its estimates of the number of options that are expected to ultimately vest. The impact of the revision of the original estimates during the vesting period, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to share options reserve.

When share options are exercised, the amount previously recognised in share options reserve will be transferred to share premium. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share options reserve will continue to be held in share options reserve.

#### Leasing

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee. All other leases are classified as operating leases.

#### The Group as lessee

Operating lease payments are recognised as an expense on a straight-line basis over the lease term. Benefits received and receivable as an incentive to enter into an operating lease are recognised as a reduction of rental expense over the lease term on a straight-line basis.

Assets held under finance leases are initially recognised as assets of the Group at their fair value at the inception of the lease or, if lower, at the present value of the minimum lease payments. The corresponding liability to the lessor is included in the consolidated statement of financial position as a finance lease obligation.

Lease payments are apportioned between finance expenses and reduction of the lease obligation so as to achieve a constant rate of interest on the remaining balance of the liability. Finance expenses are recognised immediately in profit or loss.

#### Leasehold land and building

When a lease includes both land and building elements, the Group assesses the classification of each element as a finance or an operating lease separately based on the assessment as to whether substantially all the risks and rewards incidental to ownership of each element have been transferred to the Group unless it is clear that both elements are operating leases in which case the entire lease is classified as an operating lease. Specifically, the minimum lease payments (including any lump-sum upfront payments) are allocated between the land and the building elements in proportion to the relative fair values of the leasehold interests in the land element and building element of the lease at the inception of the lease.

To the extent the allocation of the lease payments can be made reliably, interest in leasehold land that is accounted for as an operating lease is presented as "prepaid lease payments on land use rights" in the consolidated statement of financial position and is amortised over the lease term on a straight-line basis. When the lease payments cannot be allocated reliably between the land and building elements, the entire lease is generally classified as a finance lease and accounted for as property, plant and equipment.

#### **Taxation**

Income tax expense represents the sum of the tax currently payable and deferred tax.

#### Current tax

The tax currently payable is based on taxable profit for the year. Taxable profit differs from 'profit before taxation' as reported in the consolidated statement of profit or loss and other comprehensive income because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

#### Deferred tax

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax base used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary difference to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from the initial recognition of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of the reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

#### Current and deferred tax for the year

Current and deferred tax is recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

#### Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Nonmonetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. Hong Kong dollars) using exchange rates prevailing at the end of each reporting period. Income and expenses are translated at the average exchange rates for the year, unless exchange rates fluctuate significantly during the period, in which case, the exchange rates prevailing at the dates of transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of translation reserve.

## **Borrowing costs**

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

#### Retirement benefit costs

Payments to the Mandatory Provident Fund Scheme/ state-managed retirement benefit schemes are recognised as an expense when employees have rendered service entitling them to the contributions.

# 4. KEY SOURCES OF ESTIMATION UNCERTAINTY

In the application of the Group's accounting policies, which are described in note 3, the directors of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The following are key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

# Fair values of derivatives and other financial instruments

Derivative financial instruments, including foreign exchange forward contracts, are carried at the end of the reporting period at fair value as disclosed in note 19. The best evidence of fair value is quoted prices in an active market. Where quoted prices are not available for a particular financial instrument, the directors of the Company use valuation techniques with observable market inputs to the extent available to estimate the fair value. The use of methodologies, models and assumptions in pricing and valuing these financial assets and liabilities is subjective and requires varying degrees of judgement by management, which may result in significantly different fair values and results.

### Allowance for inventories

In determining the amount of allowance required for obsolete and slow-moving inventories, the directors of the Company would evaluate ageing analysis of inventories and compare the carrying value of inventories to their respective net realisable values based on latest market prices and current economic conditions. A considerable amount of judgement is required in determining such allowance. If conditions which have an impact on the net realisable value of inventories deteriorate/improve. additional allowances/reversal of allowances already made may be required.

The carrying amount of inventories as at 31st December, 2014 was HK\$111.361.000 (net of allowance for inventories of HK\$740,000) (2013: HK\$102,296,000, net of allowance for inventories of HK\$744,000).

#### Allowance for trade receivables

When there is objective evidence of impairment loss, the directors of the Company take into consideration the estimation of future cash flows. The amount of the impairment loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not been incurred) discounted at the financial asset's original effective interest rate (i.e. the effective interest rate computed at initial recognition). Where the actual future cash flows are less than expected, a material impairment loss may arise.

The carrying amount of trade receivables as at 31st December, 2014 was HK\$201,550,000 (net of allowance for doubtful debts of HK\$907,000) (2013: HK\$201,726,000, net of allowance for doubtful debts of HK\$496,000).

## Useful lives of property, plant and equipment

In applying the accounting policy on property, plant and equipment with respect to depreciation, the directors of the Company estimate the useful lives of various categories of property, plant and equipment according to their experiences over the usage of property, plant and equipment and also by reference to the relevant industrial norm. The useful lives of property, plant and equipment are reviewed annually. If the expectations differ from the previous estimates, the changes will be accounted for prospectively as changes in accounting estimates.

The carrying amount of property, plant and equipment as at 31st December, 2014 was HK\$1,371,405,000 (2013: HK\$1,429.963.000).

## 5. CAPITAL RISK MANAGEMENT

The Group manages its capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to shareholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior year.

The capital structure of the Group consists of net debt, which includes the borrowings disclosed in note 22, net of cash and cash equivalents, and equity attributable to owners of the Company, comprising issued share capital and reserves.

The directors of the Company review the capital structure on a regular basis. As part of this review, the directors of the Company consider the cost of capital and the risks associated with each class of capital. Based on recommendations of the directors of the Company, the Group will balance its overall capital structure through the payment of dividends, new share issues and share buybacks as well as the issue of new debt or the redemption of existing debt.

## (ii) Foreign exchange forward contracts

During the year, the Group has entered into several foreign exchange forward contracts with banks, details are disclosed in note 19. These derivatives are not accounted for under hedge accounting. The Group's foreign exchange forward contracts exposed the Group to foreign currency risk.

The directors of the Company consider that the exposure of HKD against USD is limited as HKD is pegged to USD.

Interest rate risk

The Group is exposed to cash flow interest rate risk in relation to variable-rate bank borrowings (see note 22 for details of these borrowings), bank balances and deposits. The directors consider that the interest rate risk on bank balances and deposits are minimal, accordingly, no sensitivity analysis is performed.

The Group's exposures to interest rates on financial liabilities are detailed in the liquidity risk section of this note. The Group cash flow interest rate risk is mainly concentrated on the fluctuation of Hong Kong Interbank Offered Rate ("HIBOR"), London Interbank Offered Rate ("LIBOR"), prevailing interest rates offered by the People's Bank of China ("PBOC") and prime rate arising from the Group's borrowings denominated in HKD and RMB respectively.

## Interest rate sensitivity analysis

The sensitivity analysis has been determined based on the exposure to interest rates for non-derivatives instruments. The analysis is prepared assuming the financial instruments outstanding at the end of the reporting period were outstanding for the whole year. Increase or decrease in a 50 basis point represents the assessment of the directors of the Company of the reasonably possible change in interest rates. For the Group's exposure to interest rates on its variable-rate bank borrowings, if interest rates had been 50 basis points higher/lower and all other variables were held constant, the Group's pre-tax profit for the year ended 31st December, 2014 would decrease/increase by HK\$2,592,000 (2013: HK\$3,228,000).

In the opinion of the directors of the Company, the sensitivity analysis is unrepresentative of the interest rate risk as the year end exposure does not reflect the exposure during the year.

#### Credit risk

As at 31st December, 2014, the Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure to discharge an obligation by the counterparties is arising from the carrying amount of the respective recognised financial assets as stated in the consolidated statement of financial position.

In order to minimise the credit risk, the directors of the Company has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group reviews the recoverable amount of each individual trade debt at the end of the reporting period to ensure that adequate impairment losses are made for irrecoverable amounts. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

The credit risk on liquid funds is limited because the counterparties are banks with high credit ratings assigned by international credit-rating agencies.

Other than concentration of credit risk on liquid funds which are deposited with several banks with high credit ratings, the Group does not have significant concentration of credit risk. Trade receivables consist of a large number of customers, spread across diverse industries and geographical areas.

In the management of the liquidity risk, the Group monitors and maintains a level of cash and cash equivalents deemed adequate by the management to finance the Group's operations and mitigate the effects of fluctuations in cash flows. The management monitors the utilisation of bank borrowings and ensures compliance with loan covenants.

The Group relies on bank borrowings as a significant source of liquidity. As at 31st December, 2014, the Group has available undrawn borrowing facilities of approximately HK\$116,740,000 (2013: HK\$205,766,000). The Group monitors its current and expected liquidity requirements regularly, ensuring sufficient liquid cash and adequate committed lines of funding from reputable financial institutions to meet the Group's liquidity requirements in the short and long term.

The following table details the Group's remaining contractual maturity for its financial liabilities. For non-derivative financial liabilities, the table has been drawn up based on the undiscounted cash flows of financial liabilities based on the earliest date on which the Group can be required to pay. Specifically, bank borrowings with a repayment on demand clause are included in the earliest time band regardless of the probability of the banks choosing to exercise their rights. The maturity dates for other non-derivative financial liabilities are based on the agreed repayment dates. The table includes both interest and principal cash flows.

The Group paid RMB12,000,000 in prior years to acquire that piece of land and the amount was previously included in the "prepaid lease payments on land use rights". The Group did not receive the formal legal title of that piece of land and the carrying amount of that piece of land as at 31st December, 2011 amounted to HK\$14,670,000. The total number of shares which may be issued upon exercise of all options to be granted under the New Scheme must not in aggregate exceed 10% of the shares of the Company in issue as at the date of the passing of the ordinary resolution for adoption of the New Scheme. The number of shares which may be issued upon exercise of all outstanding options granted and yet to be exercised at any time under the New Scheme shall not exceed 30% of the issued share capital of the Company from time to time.

#### 28. RETIREMENT BENEFIT SCHEME

#### **Hong Kong**

The Group has joined a Mandatory Provident Fund Scheme (the "MPF Scheme") for its employees in Hong Kong. The MPF Scheme is registered with the Mandatory Provident Fund Scheme Authority under the Mandatory Provident Fund Scheme Ordinance. The assets of the MPF Scheme are held separately from those of the Group in funds under the control of an independent trustee. Under the rule of the MPF Scheme, the employer and its employees are each required to make contributions to the MPF Scheme at rates specified in the rules. The only obligation of the Group with respect to the MPF Scheme is to make the required contributions under the MPF Scheme.

The retirement benefit scheme contributions arising from the MPF Scheme charged to the consolidated statement of profit or loss and other comprehensive income represent contributions payable to the funds by the Group at rates specified in the rules of the scheme.

#### **PRC**

The employees of the Group's subsidiaries in the PRC are members of a state-managed retirement benefit scheme operated by the government of the PRC. The subsidiaries are required to contribute a certain percentage of the salaries of their employees to the state-managed retirement benefit scheme. The only obligation of the Group with respect to the retirement benefit scheme is to make the required contributions under the scheme.

During the year, the retirement benefit scheme contributions amounted to approximately HK\$6,139,000 (2013: HK\$5,019,000).

#### 28. 退休福利計劃

#### 中國

#### 29. DISPOSAL OF A SUBSIDIARY

On 24th October, 2014, Hop Fung Group Company Limited ("HFGC"), a wholly-owned subsidiary of the Company, entered into two equity transfer agreements (the "Equity Transfer Agreements") with two independent third parties (the "Purchasers"). Pursuant to the Equity Transfer Agreements, HFGC agreed to sell and the Purchasers agreed to purchase 51% and 49% equity interests in FKHF, a wholly-owned subsidiary of HFGC, respectively for each purchaser, at an aggregate cash consideration of RMB380,000,000 (equivalent to HK\$481.173.000).

The entire equity transfer would be completed by two stages and within two years after completion of the first stage. The first stage of the transactions for transfer of 49% equity interest was completed on 23rd December, 2014, and the remaining 51% interests will be transferred by the end of 2016. Along with those Equity Transfer Agreements, there are contractual arrangements between HFGC and the Purchasers, limiting the HFGC's controlling power on FKHF after the completion of the first stage.

Based on all the terms and conditions of the arrangements (which were entered into at the same time and in contemplation of each other) and their economic effects, the directors of the Company consider the overall commercial effect of the two transactions is to dispose of FKHF. Furthermore, the Group ceased to exercise powers to direct the relevant activities of FKHF after the completion of the first stage of the transactions. Accordingly, the transactions are treated as a single transaction whereby the Group has lost control over FKHF at the date of completion of the first stage of the transactions. Gain on disposal of FKHF of HK\$378,802,000, which is calculated as the difference between the fair value of the consideration, net of transaction costs, and the previous carrying amount of the assets and liabilities of FKHF, is recognised in profit or loss.

#### 29. 出售附屬公司

於二零一四年十月二十四日,本公司全資附屬公 司Hop Fung Group Company Limited (「HFGC」) 與兩名獨立第三方(「該等買方」)訂立兩份股權 轉讓協議(「股權轉讓協議」)。根據股權轉讓協 議,HFGC同意出售及該等買方同意各自購買 HFGC全資附屬公司-鳳崗合豐之51%及49%股 權,總現金代價為人民幣380,000,000元(相當於 481.173.000港元)。

股權轉讓將分兩個階段進行,並將於第一階段完 成後兩年內完成。交易之第一階段(轉讓49%股 權)已於二零一四年十二月二十三日完成,餘下 51%權益將於二零一六年底前轉讓。隨著簽訂該 等股權轉讓協議,HFGC與該等買方訂立合約安 排,限制了於第一階段完成後HFGC於鳳崗合豐 之控制權。

根據該等安排(乃於同時及於經考慮彼此影響之 情況下訂立)之所有條款及條件以及彼等之經濟 利益,本公司董事認為兩項交易之整體商業影響 為出售鳳崗合豐。此外,本集團於交易之第一階 段完成後不再具有權力指示鳳崗合豐之相關業務。 因此,該等交易被視為單一交易,而本集團於交 易之第一階段完成日期失去對鳳崗合豐之控制權。 出售鳳崗合豐之收益378,802,000港元(按代價之 公平值減交易成本及鳳崗合豐資產及負債先前之 賬面值之差額計算)已於損益確認。

#### **30. CONTINGENT LIABILITIES**

The tax audits conducted by the Inland Revenue Department ("IRD") on the Company and its subsidiaries in respect of the years of assessment 2004/2005 to 2010/2011 are still on-going.

The IRD had previously issued additional assessments to Gong Ming Hop Fung Paper Ware Factory Limited ("GMHF") for the years of assessment 2004/2005 and 2005/2006 on 2nd June. 2006 and 19th October. 2006 respectively. The taxes demanded under the additional assessments amounted to HK\$11,220,917 in aggregate. The Group had lodged objections with the IRD against these additional assessments.

Subsequent to the lodgement of objections by GMHF, tax payment of HK\$1,992,965 was made during the year ended 31st December, 2006. Further, tax reserve certificates of HK\$1,717,279 in respect of the 2005/2006 assessments for GMHF, pending the outcome of the tax audits and the objections, were purchased in December 2006 and included in "deposits and prepayments" as at 31st December, 2014 and 31st December, 2013. Also, banker's undertakings of HK\$3,828,453 were arranged by the Group and had been accepted by the IRD as security for payment of the mentioned tax. The remaining amounts of tax of HK\$3,682,220 demanded by the IRD have been held over unconditionally.

In addition, the IRD issued protective assessments to certain subsidiaries of the Group, namely Chun Yik (Macao Commercial Offshore) Limited ("CYMCO"), Man Shung (Macao Commercial Offshore) Limited ("MSMCO") and FKHF, for the year of assessment 2005/2006 in March 2012, amounted to HK\$525,000 in aggregate. The Group lodged objections with the IRD against these protective assessments.

Furthermore, the IRD issued protective assessments to the Company and certain subsidiaries of the Group. namely CYMCO, MSMCO, FKHF, and GMHF, for the year of assessment 2006/2007, 2007/2008 and 2008/2009 in March 2013, March 2014 and March 2015 respectively, amounted to HK\$4,469,958 in aggregate. A tax reserve certificate of HK\$175,000 in respect of the 2007/2008 assessments for the Company, CYMCO, MSMCO, FKHF and GMHF, pending the outcome of the tax audits and the objections, was purchased in June 2014. In September 2014, the IRD further issued protective assessment to GMHF for the year of assessment 2008/2009 to 2010/2011 amounted to HK\$106,614 in aggregate of which a tax reserve certificate was purchased in November 2014. The Group lodged objections with the IRD against these protective assessments.

### 30. 或然負債

就二零零四年/二零零五年至二零一零年/二零 一一年課税年度而言,香港税務局(「税務局」)就 本公司及其附屬公司之税務審核仍在進行中。

税務局早前分別於二零零六年六月二日及二零零 六年十月十九日就公明合豐紙品廠有限公司(「公 明合豐」)之二零零四年/二零零五年及二零零五 年/二零零六年課税年度發出額外評税。根據額 外評税所需繳付之税項合共為11.220.917港元。 本集團已就該等額外評税向税務局提出反對。

截至二零零六年十二月三十一日止年度,公明合 豐遞交反對書後,已支付税項1.992.965港元, 並於二零零六年十二月就公明合豐之二零零五年 /二零零六年評税購買1,717,279港元儲税券, 以待税務審核及提出反對之結果。此儲税券金額 於截至二零一四年十二月三十一日及二零一三年 十二月三十一日止年度已計入「按金及預付款」 內。再者,本集團已安排銀行承擔3,828,453港元 作為支付上述税款之抵押, 而税務局已接受該抵 押。税務局所要求之其餘税項3.682.220港元已 獲無條件暫緩。

此外,税務局於二零一二年三月就本集團若干附 屬公司(分別為進益(澳門離岸商業服務)有限公 司(「進益澳門」)、萬順(澳門離岸商業服務)有 限公司(「萬順澳門」)及鳳崗合豐)之二零零五年 /二零零六年課税年度發出保障性評税,合共為 525,000港元。本集團已就該等保障性評稅向稅 務局提出反對。

此外,税務局分別於二零一三年三月、二零一四 年三月及二零一五年三月就本公司及本集團若干 附屬公司(分別為進益澳門、萬順澳門、鳳崗合 豐及公明合豐)之二零零六年/二零零七年、二 零零七年/二零零八年及二零零八年/二零零九 年課税年度發出保障性評税,合共為4.469.958 港元。本公司於二零一四年六月就本公司、進益 澳門、萬順澳門、鳳崗合豐及公明合豐之二零零 七年/二零零八年評税購買175.000港元儲税券, 以待税務審核及提出反對之結果。於二零一四年 九月,税務局就公明合豐之二零零八年/二零零 九年至二零一零年/二零一一年課税年度發出保 障性評税,合共為106,614港元。本公司於二零 一四年十一月就該評税購買儲税券。本集團已就 該等保障性評税向税務局提出反對。

Moreover, the IRD issued protective assessment to a subsidiary of the Group, namely Top Develop Limited, for the year of assessment 2008/2009 in March 2015, amounted to HK\$165,000. The Group lodged objection with the IRD against the protective assessment.

The directors believe that no additional provision for Hong Kong Profits Tax in respect of the tax audit for the years of assessment 2004/2005 and onwards is necessary at the present stage. The directors consider that the inquiries from the IRD are still at a fact-finding stage and the IRD has yet expressed any formal opinion on the potential tax liability, if any. The potential tax liability, if any, cannot be readily ascertained at this stage.

#### 31. RELATED PARTY TRANSACTIONS

The remuneration of directors, who are key management of the Group, during the year are disclosed in note 12. The remuneration of executive directors, who are also the key executives of the Group, is determined by the remuneration committee having regard to the performance of individuals and market trends.

#### 32. MAJOR NON-CASH TRANSACTIONS

During the year, HFGC has entered into Equity Transfer Agreements to dispose its 100% equity interests in FKHF by two stages at total consideration of HK\$481,173,000. First payment of HK\$235,857,000 has been received from the Purchasers during this year and amount of HK\$245,316,000 will be settled by the end of 2016.

In respect of the disposal of FKHF, transaction costs of HK\$61,055,000 are accounted for as trade, bills and other payables, at the end of the reporting period.

Further details of the disposal of FKHF are set out in note 29.

During the year, the Group entered into finance lease arrangements in respect of a motor vehicle with a total capital value at the inception of the leases of HK\$800,000 with initial payment of HK\$66,000 being paid, and the amount has been fully repaid as at year end.


