The board of directors of the Company (the "Board") hereby announces that the Group's contracted sales for the three months ended 31 March 2014 amounted to approximately RMB703 million, representing a decrease of 73.5% as compared to approximately RMB2,650 million in the same period of last year, with a gross floor area of approximately 36,052 square metres. For the three months ended 31 March 2014, the Group's average selling price of contracted sales recorded RMB19,507 per square metre, representing a drop of 10.5% year-on-year compared to RMB21,787 per square metre in the same period of last year. In March, the Group recorded a single month's contracted sales of approximately RMB232 million. In light of the various uncertainties that may occur during the sales process, there may be variations between the above mentioned sales figures and the final figures disclosed in the Company's periodical sales reports.
