Online Attendance at the AGM

In addition to physical attendance, you, as a Non-registered Holder whose shares are held in the Central Clearing and Settlement System ("CCASS") through banks, brokers, custodians, nominees or HKSCC Nominees Limited (together, the "Intermediary") have the option of attending, participating and voting at the AGM through online access by visiting https://web.lumiagm.com. If you attend the AGM online, you will be able to view a live webcast of the AGM, cast your vote on the resolutions in real time and submit online questions to the Company. The online platform will be open for shareholders to log in approximately 30 minutes prior to the commencement of the AGM (i.e. around 12:00 noon on 10 May 2021).

In order to attend the AGM online, you need to (i) contact your Intermediary to appoint you as a proxy and (ii) provide your e-mail address to your Intermediary, before the time limit required by your Intermediary. Details regarding the AGM arrangements including the login details to access the AGM online platform will be sent by Computershare Hong Kong Investor Services Limited, the Hong Kong Share Registrar of the Company (the "HK Share Registrar") to the e-mail address provided by you.

Please keep the login details in safe custody for use at the AGM and do not disclose them to anyone else.
