

## 3 Hong Kong to offer iPad Air 2 and iPad mini 3 on 24 Oct 2014 (with tariff plans)

- 2. Wi-Fi is applicable to designated hotspots. When the Wi-Fi signal is weak or unavailable, service may automatically be accessed by mobile data and mobile data charge will incur based on user's monthly tariff plan.
- 3. A message alert will be sent to the customer when data usage nearly reaches the limit. Customer may through www.three.com.hk or 3Meter App purchase data top-up which can be used for the remaining period of the month before bill cut-off date. If data usage has reached the limit, local data usage will be suspended.
- 4. For minimal data usage triggered by handset applications during the period of suspension of local data usage, or unbilled data usage due to cut-off time difference or delay, they will be deducted upon top-up of additional data during that bill month.
