(1) A maximum of 520,000,000 Conversion Shares (upon full conversion of possibly be issued Convertible Notes) may possibly be issued in relation to a memorandum of understanding signed on 31 January 2010 and agreements signed on 22 October 2010. Conversion Price of the possible issue of Shares is HK\$0.6.

(2) On 10 September 2015, the Company entered into the non-legally binding Memorandum of Understanding with the Subscriber, pursuant to which the Subscriber intended to subscribe, and the Company intended to allot and issue 6,000,000,000 Subscription Shares at the Subscription Price of HK\$0.16 upon completion of the Possible Subscription. Please refer to the Company's announcement dated 10 September 2015.
