# PLACING OF NEW SHARES

On 26 April 2010 (after trading hours), the Company entered into the Placing Agreement with the Placing Agent whereby the Company agreed to place, through the Placing Agent, on a best effort basis, a maximum of 375,000,000 new Shares to not less than six Placees at a price of HK\$0.133 per Placing Share.
