# PARTNER COMMUNICATIONS ANNOUNCES IT RECEIVED A LAWSUIT REQUESTING CERTIFICATION AS A CLASS ACTION

Rosh Ha'ayin, Israel, September 22, 2008 – Partner Communications Company Ltd.
