MONTHLY ANNOUNCEMENT RELATING TO OUTSTANDING BONDS

Reference is made to the Company's announcements dated 14 November 2007 and 27 December 2007 (the "Announcements") and the circular of the Company dated 5 December 2007 (the "Circular") in relation to, among other things, the Long Grand Subscription Agreement and the Placing Agreement. - (d) as at 1 January 2008 and 31 January 2008, the issued share capital of the Company was HK\$3,370,310.16 divided into 337,031,016 Shares.
