Pursuant to a deed of variation dated 18 February 2019 executed by the Company and Internet Finance Investment Co., Ltd., the maturity date of the convertible bonds was extended from 18 February 2019 to 18 February 2020 and additional convertible bonds in the principal amount of HK\$5,000,000 was issued to Internet Finance Investment Co., Ltd. EGM approval date is 18 June 2019. On 25 March 2020, the bondholder holding HK\$100,000,000 principal amount of the convertible bonds made an irrevocable undertaking that it agreed to extend the maturity date of the convertible bonds from 18 February 2020 to 18 February 2022, subject to approval from independent shareholders of the Company and The Stock Exchange of Hong Kong Limited.
