1. As at 28 Febr	uary 2021, the convertible bonds with the principal amount of HK\$105,000,000 was overdue. Upon maturity
of the convert	tible bonds in February 2020, the Company has been negotiating renewed terms with the bondholders. The
Company inte	nds to repay the convertible bonds from the net proceeds of the rights issue/subscription of the Company as
disclosed in th	e announcement and circular of the Company dated 11 September 2020 and 4 November 2020 respectively and
being complet	ed in January 2021. Upon the share consolidation (10 to 1) of the Company becoming effective on 1 December
2020, the rele	vant conversion price per consolidated shares has been HK\$10.00. As a result of the completion of the rights
issue on 14 Ja	anuary 2021 and the subscription on 25 January 2021 and pursuant to the terms of the Convertible Bonds,
the conversion	price of the outstanding Convertible Bonds has further been adjusted to HK\$7.91 per share.
