## 1. INTRODUCTION

The purpose of this circular is to give you information regarding the ordinary resolutions to be proposed at the Annual General Meeting to enable the Shareholders to make an informed decision on whether to vote for or against the resolutions, and the notice of the Annual General Meeting.

The ordinary resolutions to be proposed at the Annual General Meeting include, inter alia, (i) the grant of general mandates to issue and repurchase Shares; and (ii) the re-election of Directors.

#### 2. GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

At the last annual general meeting of the Company held on 12 December 2012, ordinary resolutions were passed giving general mandates to the Directors to exercise the powers of the Company to issue and repurchase Shares. Such general mandates will expire at the conclusion of the Annual General Meeting.

At the Annual General Meeting, the following ordinary resolutions relating to the granting to the Directors the new and unconditional mandates to exercise the powers of the Company to issue and repurchase Shares will be proposed:

This is an explanatory statement given to all Shareholders relating to a resolution to be proposed at the Annual General Meeting for approving the Repurchase Mandate. This explanatory statement contains all the information required pursuant to Rule 10.06(1)(b) and other relevant provisions of the Listing Rules which are set out as follows:

#### 1. SHARE CAPITAL

As at the Latest Practicable Date, the entire issued share capital of the Company comprised 1,080,693,024 Shares.

Exercise in full of the Repurchase Mandate, on the basis that no further Shares will be issued or repurchased prior to the date of the Annual General Meeting, could accordingly result in up to 108,069,302 Shares, representing approximately 10% of the entire issued share capital of the Company as at the date of passing of the resolution, being repurchased by the Company.

#### 2. REASONS FOR REPURCHASE

The Directors believe that it is in the best interests of the Company and its Shareholders to seek a general authority from Shareholders to enable the Directors to repurchase the Shares in the market.
