The bondholder has the optioned to convert the Convertible Bonds into ordinary shares of the Company of HK\$0.01 each at a conversion price of HK\$0.43. Unless previously converted, purchased or redeemed, each Convertible Bond shall be redeemed by the Company at 100% of its principal amount on 25 March 2015 (the maturity date of the Convertible Bonds). As at the report date, there are remaining HK\$1,073,000,000 convertible bonds outstanding.
