Convertible Bonds

On 25 March 2010, the Company issued a 1% convertible bond with an aggregate amount of HK\$1,098,000,000. The bondholder has the option to convert the convertible bond into ordinary shares of the Company of par value of HK\$0.01 each at a conversion price of HK\$0.43. Unless previously converted, purchased or redeemed, each convertible bond shall be redeemed by the Company at 100% of its principal amount on 25 March 2015, being the maturity date of the convertible bonds. On 16 September 2010, the Company had redeemed part of outstanding convertible bonds at an amount HK\$25,000,000 which was equal to 100% o of the principal amount of the redeemed portion. On 29 May 2012, the Company had disposed of its certain prepaid land lease payments, property and equipment which were classified as assets held for sale in the Company's annual report of 2012. The sales proceeds is settled by the aforesaid convertible bond with a principal amount of HK\$170,599,500. As at the reporting date, an aggregate principal amount of HK\$902,400,500 convertible bonds are remained outstanding.
