On 28 August 2015 (after trading hours of the Stock Exchange), the Company entered into the Placing Agreement with Pico Zeman Securities (HK) Limited (“Placing Agent”), pursuant to which the Placing Agent agreed amongst other things to procure not less than six Placées to subscribe for up to HK\$250 million of the Convertible Bonds on a best effort basis by one or more tranches of not less than HK\$10 million at the initial conversion price of HK\$0.05 per Conversion Share. Assuming the Convertible Bonds are fully placed, upon full conversion of the Convertible Bonds at the Conversion Price, a total of 5,000,000,000 Shares will be issued.
