STATUTORY DEMAND FROM CREDITOR

This announcement is made under the requirement of Rule 17.10 of the Rules Governing the Listing of Securities on the Growth Enterprise Market (“**GEM**”) of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of Code Agriculture (Holdings) Limited (the “**Company**”) announces that on 15 November 2017, the Company received a statutory demand (the “**Statutory Demand**”) dated 15 November 2017 issued by the legal representative of Artic Blue Corporation demanding the Company to repay a total sum of HK\$58,186,207.11 (the “**Outstanding Amount**”). The Statutory Demand was issued pursuant to section 178 of the Companies (Winding Up and Miscellaneous Provisions) Ordinance, Chapter 32 of the Laws of Hong Kong. If the Company fails to repay the Outstanding Amount within 21 days, a winding-up order may be made in respect of the Company.

The Company is actively negotiating with the creditor for settlement method(s) of the Outstanding Amount and is also seeking legal advice on the matter. Further announcement will be made as and when appropriate.
